13 **18448, under Planning Code Section 209.6(b) to install a wireless telecommunications service**  
14 **facility consisting of up to six panel antennas and related equipment in an existing church as part**  
15 **of AT&T's Wireless Telecommunications Network within the RH-3 (Residential, House, Three-**  
16 **Family) District and a 40-X Height and Bulk District, on property located at:**

17 **2041 Larkin Street, Assessor's Block No. 0572, Lot No. 003**

18 **be and the same is disapproved; and be it.**

19 **FURTHER MOVED, That the Board of Supervisors hereby approves the issuance of**  
20 **Conditional Use Application identified as Planning Case No. 2010.1083C on property located**  
21 **at 2041 Larkin Street, subject to all of the conditions imposed by the Planning Commission in**  
22 **its Motion No. 17959, dated September 22, 2011, and further subject to the following**  
23 **additional conditions imposed by the Board of Supervisors on December 6, 2011:**

24 **1. Use is authorized as long as an independent evaluator, selected by the Planning**  
25 **Department with input from parties, determines that the information and conclusions**

1 submitted by AT&T in support of its request for conditional use are accurate. AT&T shall fully  
2 cooperate with the evaluator and shall provide any and all data requested by the evaluator to  
3 allow the evaluator to verify that the maps, data, and conclusions about service coverage  
4 submitted by AT&T are accurate. AT&T shall bear all costs of said evaluation. The  
5 independent evaluator, upon request by AT&T, shall keep the submitted data confidential and  
6 shall sign a confidentiality agreement acceptable to AT&T. The independent evaluator shall  
7 be a professional engineer licensed by the State of California.
