3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle
6 Code and the San Francisco Traffic Code, the following regulations governing the
7 parking of vehicles are hereby enacted or rescinded as designated below:

8 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

- 9 Octavia Boulevard, both sides, between Hayes and Market Streets;
- 10 Fell Street, north side, between Frontage Road and Octavia Boulevard;
- 11 Octavia Frontage Road, east side, from Market Street to 140 feet northerly;
- 12 Octavia Frontage Road, east side, from Haight Street to 40 feet northerly;
- 13 Rose Street, north side, from Octavia Frontage Road to 30 feet easterly;
- 14 Octavia Frontage Road, east side, from Haight Street to 40 feet northerly;
- 15 Octavia Frontage Road, east side, from Page Street to 40 feet northerly;
- 16 Octavia Frontage Road, east side, from Oak Street to 40 feet northerly;
- 17 Octavia Frontage Road, west side, from Fell Street to 24 feet southerly;
- 18 Octavia Frontage Road, west side, from Oak Street to 40 feet southerly;
- 19 Lily Street, south side, from Octavia Frontage Road to 26 feet westerly;
- 20 Octavia Frontage Road, west side, from Haight Street to 60 feet southerly;
- 21 Oak Street, both sides, from Gough Street to 22 feet easterly; and
- 22 Oak Street, both sides, from 98 feet west of Franklin Street to 149 feet westerly.

Oak Street, north side, from Octavia Street to Laguna Street.


