

1 [Revising Double Parking Restrictions for Municipal Railway Bus Routes on Stockton Street.]

3 **Ordinance amending the San Francisco Traffic Code by amending Section 53 to revise**
4 **restrictions on double parking on Municipal Railway Bus Routes on Stockton Street.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Traffic Code is hereby amended by amending Section
10 53, to read as follows:

11 **SEC. 53. DOUBLE PARKING**

12 A vehicle parked in violation of Section 22500 (h) of the Vehicle Code of the State of
13 California by being stopped, parked, or left standing on the roadway side of any vehicle
14 stopped, parked, or standing at the curb or edge of a highway, except for a schoolbus when
15 stopped to load or unload pupils in a business or residence district where the speed limit is 25
16 miles per hour or less, shall be cited by the appropriate authority as a violation of the statute.

17 *Any person violating Section 22500(h) shall be deemed guilty of an infraction and upon the*
18 *conviction thereof shall be punished by a fine of not less than \$50 nor more than \$100.*

19 (a) No person shall stop, park, or leave standing any vehicle such that any
20 portion of the vehicle is within a Municipal Railway bus route on restricted streets. The
21 restricted streets are Chestnut Street, Union Street, Clay Street, Stockton Street, from
22 Columbus Avenue to Market Street, Mission Street, Geary Street, Polk Street, Sacramento
23 Street, Clement Street, Fillmore Street, Haight Street, Irving Street, 9th Avenue, 16th Street,
24 and 24th Street. No person shall stop, park, or leave standing in any portion of a Municipal
25 Railway bus route on such street his or her vehicle between the hours of 6:00 a.m. to 9:00

1 a.m. and from 4:00 p.m. to 7.00 p.m. In addition, no person shall stop, park, or leave standing his
2 or her vehicle in any portion of a Municipal Railway bus route on Stockton Street from Broadway to
3 Jackson Street, between the hours of 6:00 a.m. to 7:00 p.m.. Any person violating this Section shall be
4 subject to a fine of \$100.00. The Department of Parking and Traffic shall install signs and
5 otherwise alert motorists where and when this prohibition shall take effect and the applicable
6 fine. This section shall not apply to vehicles engaged in emergency services including, but not
7 limited to, fire engines, police vehicles, ambulances, or public utility vehicles while such
8 vehicles are operating, maintaining, or repairing facilities of the public utility or are being used
9 in connection with providing public utility service.

10 (b) No person shall stop, park, or leave standing any vehicle such that any
11 portion of the vehicle is stopped, parked, or standing in front of a legally permitted medical
12 cannabis dispensary in violation of California Vehicle Code section 22500(h). ~~Any person~~
13 ~~violating this subsection shall be subject to a fine of \$100.00.~~ The Department of Parking and
14 Traffic shall install signs and otherwise alert motorists where and when this prohibition shall
15 take effect and the applicable fine. This subsection shall not apply to vehicles engaged in
16 emergency services including, but not limited to, fire engines, police vehicles, ambulances, or
17 public utility vehicles while such vehicles are operating, maintaining, or repairing facilities of
18 the public utility or are being used in connection with providing public utility service.
