RESOLVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated person to serve as a member of the Lead Hazard Reduction Citizens Advisory Committee, pursuant to the provisions of the San Francisco Health Code, Section 1608, for the term specified:

James Hutchinson, succeeding Marvin Ruiz, resigned, Seat No. 2, must represent the Bureau of Building Inspection, DPW, or designee, for the unexpired portion of a 4-year term ending December 22, 2003.

FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the Lead Hazard Reduction Citizens Advisory Committee has a goal to be representative of the diversity of the City and County of San Francisco.
- Applicant James Hutchinson, a new appointee, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him/her to serve on the Lead Hazard Reduction Citizens Advisory Committee.
- 3. The Lead Hazard Reduction Citizens Advisory Committee has attempted to fill the position, for which James Hutchinson was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that James Hutchinson is qualified to serve on the Lead Hazard Reduction Citizens Advisory Committee.

4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Lead Hazard Reduction Citizens Advisory Committee at this time; and, be it

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for James Hutchinson, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
