3	Resolution determining that the issuance of a Type-90 on-sale general music
4	venue liquor license to SR Visions, LLC, to do business as 7 Social, located at 65
5	Post Street (District 3), will serve the public convenience or necessity of the City
6	and County of San Francisco, in accordance with California Business and
7	Professions Code, Section 23958.4; and requesting that the California Department
8	of Alcoholic Beverage Control impose conditions on the issuance of the license.
9	
10	WHEREAS, SR Visions, LLC is seeking the issuance of a Type-90 on-sale
11	general music venue liquor license to do business as 7 Social located at 65 Post Street
12	(District 3); and
13	WHEREAS, The Planning Department has verified that the area is properly
14	zoned and recommends approval; and
15	WHEREAS, The Police Department has filed zero protests and zero letters of
16	support with the Department of Alcoholic Beverage Control under California Business
17	and Professions Code, Section 24013, and recommends that the Department of
18	Alcoholic Beverage Control issue the liquor license with conditions; and
19	WHEREAS, The conditions recommended by the Police Department are the
20	following: 1) Petitioner(s) shall actively monitor the area under their control in an effort
21	to prevent the loitering of persons on any property adjacent to the licensed premises as
22	depicted on the ABC-253; 2) The petitioner(s) shall be responsible for maintaining free
23	of litter the area adjacent to the premises over which they have control, as depicted on
24	ABC-253; 3) (1) Except as provided in Condition 2 below, no noise shall be audible
25	beyond the area under the control of the licensee. (2) Any noise caused by

1 entertainment or amplified sound that is subject to the provisions of an active 2 Entertainment Permit issued by the San Francisco Entertainment Commission shall be 3 authorized in accordance with the limits established by that Entertainment Permit, including any limitation on hours during which entertainment or amplified sound is 4 5 permitted. A violation of the entertainment or amplified sound noise conditions of the 6 Entertainment Permit, as determined by the San Francisco Entertainment Commission 7 (or any successor agency), shall be deemed to be a violation of this Condition. Any 8 noise that is not subject to, or is beyond the scope of, the Entertainment Permit shall be 9 subject to Condition 1 above. "Entertainment Permit" means any of the following: a Just Add Music permit, a Limited Live Performance permit, a Place of Entertainment permit, 10 a Fixed Place Amplified Sound permit, or any similar such permit issued by the San 11 12 Francisco Entertainment Commission; and 4) At any time, the premise is providing live 13 entertainment, the petitioner(s) shall have two (2) uniformed security guard(s) on the 14 premises and shall maintain order therein to prevent any activity which would interfere 15 with the guiet enjoyment of their nearby residents, or the surrounding community. The 16 uniform security guards must be licensed by the State of California Department of Consumer Affairs; now, therefore, be it 17 18 RESOLVED, That in accordance with California Business and Professions Code, 19 Section 23958.4, the Board of Supervisors of the City and County of San Francisco 20 hereby determines that issuance of a Type-90 on-sale general music venue liquor 21 license to SR Visions, LLC, to do business as 7 Social located at 65 Post Street, will 22 serve the public convenience or necessity of the City and County of San Francisco; and, 23 be it 24 FURTHER RESOLVED, That the Board of Supervisors of the City and County of

San Francisco hereby endorses and adopts the recommendations of the Police
