

1 [Professional Services Contract - ConnectionsCA, LLC. - RESET Center - Not to Exceed  
2 \$14,537,426]

3 **Resolution approving and authorizing the City and County of San Francisco acting**  
4 **through the Sheriff's Office to enter into a Professional Services Contract with**  
5 **ConnectionsCA, LLC for operating the Rapid Enforcement Support Evaluation and**  
6 **Triage (RESET) Center, a safe alternative to incarceration for individuals brought in by**  
7 **law enforcement for public intoxication or drug use, submitted under Chapter 21B of**  
8 **the Administrative Code as a Core Initiative Contract, for a total not to exceed amount**  
9 **of \$14,537,426 with an initial term of two years and two months, commencing on**  
10 **February 1, 2026, through March 31, 2028, with an option to extend for one additional**  
11 **year; authorizing the Sheriff to execute any amendments, make certain modifications**  
12 **and take certain actions that do not materially increase the obligations or liabilities to**  
13 **the City, and are necessary or advisable to effectuate the purposes of the contract; and**  
14 **affirming the Planning Department's determination under the California Environmental**  
15 **Quality Act.**

16  
17 WHEREAS, On February 11, 2025, the Board of Supervisors adopted Ordinance  
18 No. 010-25, codified in Chapter 21B of the Administrative Code, to suspend and delegate  
19 certain approvals for Contracts and Leases necessary to accelerate the City's response to  
20 homelessness, drug overdoses and substance use disorders, mental health needs, integrated  
21 health needs, and public safety hiring (the "Core Initiatives"); and

22 WHEREAS, In March 2025, Mayor Lurie released "Breaking the Cycle", an executive  
23 directive to break cycles of homelessness and addiction by enabling more effective  
24 coordination across departments and outlining both immediate actions and longer-term  
25 reforms with the goals of attaining: 1) a system that helps people achieve lasting stability,

1 2) cleaner and safer sidewalks, and 3) more responsible governance and accountable  
2 services; and

3 WHEREAS, The Sheriff's Office seeks to contract with a service provider to operate the  
4 Rapid Enforcement Support Evaluation and Triage ("RESET") Center, a voluntary facility that  
5 is an alternative to jail and hospitalization for individuals under the influence of intoxication,  
6 controlled substance or drugs; and

7 WHEREAS, The Sheriff's Office offers alternatives to jail such as Pretrial Diversion and  
8 Electronic Monitoring, and often paired with mental health and substance abuse treatment to  
9 keep offenders productive, reduce jail populations, and allow people to stay employed and  
10 with family while meeting the requirements of the Court; and

11 WHEREAS, The contract is necessary to meet the Core Initiatives of projects  
12 addressing drug overdoses and substance use disorders as part of the Sheriff's Office's  
13 overall overdose prevention and crime reduction strategies; and

14 WHEREAS, The contract offers an alternative to jail and hospitalization by filling a gap  
15 in interventions for people who are arrested for intoxication or being under the influence of a  
16 controlled substance or drug and engaged in disordered behavior; and

17 WHEREAS, The Sheriff's Office in partnership with the Department of Public Health,  
18 Police Department, District Attorney's Office, and Fire Department will support the operations  
19 of the RESET Center; and

20 WHEREAS, The Sheriff's Office desires to enter into a contract with ConnectionsCA,  
21 LLC. under the authority of Administrative Code, Chapter 21B.3(b); and waive the competitive  
22 bid requirements; and

23 WHEREAS, Contractor represents and warrants that it is qualified to perform the  
24 services required by the City; and

1           WHEREAS, The contract is consistent with the Civil Service Commission's approval  
2 obtained on December 1, 2025, under Personal Service Contract No. DHRPSC0005790; and

3           WHEREAS, Charter, Section 9.118(b), requires Board of Supervisors' approval by  
4 Resolution of the contract; and

5           WHEREAS, The Planning Department has determined that the actions contemplated in  
6 this Resolution comply with the California Environmental Quality Act (California Public  
7 Resources Code, Sections 21000 et seq.); said determination is on file with the Clerk of the  
8 Board of Supervisors in File No. 260028 and is incorporated herein by reference; and

9           WHEREAS, The proposed contract contained in File No. 260028, is substantially in  
10 final form, with all material terms and conditions included, and only remains to be executed by  
11 the parties upon approval of this Resolution; now, therefore, be it

12           WHEREAS, The Mayor introduced this Resolution under Section 21 B.3(c) of the  
13 Administrative Code; if the Board of Supervisors fails to act on the Resolution within the  
14 timeframe identified in Section 21 B.3(c)(6), the Mayor will have authority to approve the  
15 contract identified below; and

16           RESOLVED, That the Board of Supervisors hereby approves the contract in  
17 substantially the form contained in File No. 260028; and, be it

18           FURTHER RESOLVED, That the Board of Supervisors affirms the Planning  
19 Department's California Environmental Quality Act determination for the same reasons set  
20 forth in the determination in Board File No. 260028, and incorporates such findings by  
21 reference as though fully set forth herein, and, be it

22           FURTHER RESOLVED, That the Board of Supervisors authorizes the Sheriff's Office  
23 to make any modifications to the contract, prior to its final execution by all parties, that the  
24 Sheriff's Office determines, in consultation with the City Attorney, are consistent with this  
25 Resolution, in the best interest of the City, do not materially increase the obligations or

1 liabilities of the City, are necessary or advisable to effectuate the purposes of the contract,  
2 and are in compliance with all applicable laws, including City's Charter; and, be it

3 FURTHER RESOLVED, That within 30 days of the contract being fully executed by all  
4 parties, the Sheriff's Office shall submit to the Clerk of the Board of Supervisors a completely  
5 executed copy for inclusion in File No. 260028; this requirement and obligation resides with  
6 the Department and is for purposes of having a complete file only, and in no manner affects  
7 the validity of approved contract.
