WHEREAS, Section 308 of the San Francisco Planning Code outlines the right of appeal of any amendment, conditional use or variance by the Planning Commission or any determination by the Zoning Administrator; and

WHEREAS, Section 308.1 reads: "Any appeal under this Section shall be taken by filing written notice of appeal with the Board of Supervisors within 30 days after the date of action by the Planning Commission"; and,

WHEREAS; Section 308.2 reads: "Any appeal under this Section shall be taken by filing written notice of appeal with the Board of Appeals within 10 days after the date of the written variance decision of the Zoning Administrator or within 15 days of any other written determination of the Zoning Administrator"; and,

WHEREAS, The lack of knowledge of such a time limit or due process may hinder one's right of appeal; and,

WHEREAS, The website of the Planning Department does not contain information concerning the appeals process that is clear or easily accessible to the public; now, therefore, be it

RESOLVED, That the Board of Supervisors urge the Planning Department to place all relevant information concerning the appeals process on their website in a clear and accessible format; and, be it
