3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**  
4 **and expend retroactively a grant in the amount of \$20,000 from The San Francisco**  
5 **Foundation, to assist with a project entitled “Early Childhood Mental Health**  
6 **Consultation Initiative;” for the period of June 1, 2010 through May 31, 2011.**

8 WHEREAS, The Department of Public Health is the recipient of a grant award from The  
9 San Francisco Foundation to fund a project entitled “Early Childhood Mental Health  
10 Consultation Initiative;” and,

11 WHEREAS, Through this grant, The San Francisco Foundation has agreed to fund  
12 DPH in the amount of \$20,000 the period of June 1, 2010 through May 31, 2011; and,

13 WHEREAS, As a condition of receiving the grant funds, the San Francisco Foundation  
14 requires the City to enter into an agreement (the “Agreement”), a copy of which is on file with  
15 the Clerk of the Board of Supervisors in File No. 100936; which is hereby declared to be a  
16 part of this resolution as if set forth fully herein; and,

17 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH  
18 for one existing position, Senior Community Development Specialist I (Job Class #9774) at  
19 0.20 FTE; and,

20 WHEREAS, A request for retroactive approval is being sought because the Agreement  
21 was not approved until May 6, 2010; and,

22 WHEREAS, The budget does not include a provision for indirect costs in order to  
23 maximize the use of grant funds on direct services; now therefore, be it

24 **RESOLVED, That DPH is hereby authorized to accept and expend a grant retroactively**  
25 **in the amount of \$20,000 from The San Francisco Foundation and, be it**


4 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
