

1 [Contract Approval - Andrews International - Armed and Unarmed Security Services - Not to  
2 Exceed \$29,226,586.68]

3 **Resolution approving the contract between the San Francisco Municipal**  
4 **Transportation Agency (SFMTA) and Andrews International to provide armed and**  
5 **unarmed security services for an amount not to exceed \$29,226,586.68 for an initial**  
6 **three year term of September 15, 2014, through August 31, 2017, with an option to**  
7 **extend for up to three additional years at the SFMTA's sole discretion.**

9 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) collects  
10 more than \$210 million in annual revenue from transit fares, citation payments, and sale of  
11 various fare media and has facilities throughout the City, including transit stations, vehicle  
12 storage yards and service centers; and

13 WHEREAS, The SFMTA's facilities require the services of security guards to act as a  
14 first deterrent for inappropriate activity, ensure the safety of SFMTA personnel, protect  
15 SFMTA property and the public, and guard against vandalism; and

16 WHEREAS, The current contract with Cypress Security, LLC expires on September 30,  
17 2014; and

18 WHEREAS, On June 24, 2014, the SFMTA Board of Directors authorized the Director  
19 of Transportation to issue an Invitation for Bids No. SFMTA-2014-27 - Armed and Unarmed  
20 Security Services; and

21 WHEREAS, On July 16, 2014, the SFMTA received and publically opened three bids;  
22 and

23 WHEREAS, The SFMTA determined that Andrews International is the responsible  
24 contractor who submitted the lowest bid, in the amount of \$29,226,586.68; and

1           WHEREAS, The Contract Compliance Office reviewed the bid proposals and confirmed  
2 that Andrews International will meet the Local Business Enterprise (LBE) participation goal of  
3 20% established for this Contract; and

4           WHEREAS, On September 2, 2014, the SFMTA Board of Directors adopted Resolution  
5 No. 14-138, which authorized the Director of Transportation to execute Contract No. SFMTA-  
6 2014-27 with Andrews International to provide armed and unarmed security services in the  
7 amount of \$29,226,586.68, for an initial term of three years with an option to extend the term  
8 for up to three additional years at the SFMTA's sole discretion; and

9           WHEREAS, San Francisco Charter, Section 9.118 provides that the Board of  
10 Supervisors must approve contracts with anticipated expenditures of \$10,000,000 or more;  
11 and

12           WHEREAS, A copy of the said contract is on file with the Clerk of the Board of  
13 Supervisors in File No. 140871, which is hereby declared to be part of this motion as if set  
14 forth fully herein; now, therefore, be it

15           RESOLVED, That the Board of Supervisors authorizes the SFMTA to enter into a  
16 contract with Andrews International for an amount not to exceed \$29,226,586.68, and an  
17 initial term of three years with an option to extend for up to three additional years at the  
18 SFMTA's sole discretion; and, be it

19           FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed  
20 by all parties the SFMTA shall provide the final contract to the Clerk of the Board for inclusion  
21 into the official file.
