9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this
12 Ordinance are in compliance with the California Environmental Quality Act (California Public
13 Resources Code sections 21000 et seq.).

14 Section 2. The San Francisco Park Code is hereby amended by amending Section
15 12.05, to read as follows:

16 SEC. 12.05. JAPANESE TEA GARDEN.

17 (a) The following fees shall be charged for admission to the Japanese Tea Garden:

18 Age Category	Admission Fee
19 Adult	\$3.50 <u>4.00</u>
20 Adult with Muni Pass	\$2.00
21 Senior	\$1.25 <u>1.50</u>
22 Child (6-12 years)	\$1.25 <u>1.50</u>
23 Child (under 6 years)	\$0.00

1 **(b)** Audio Tours: Upon development, and approval by the Commission, of an audio tour for
2 the facility, the entrance fee for the facility shall be increased by \$1.00 to cover the cost of rental of the
3 tour.

4 **(c)** The first hour and last hour of each day is fee of charge to all visitors. Recreation and
5 Park Commission is authorized to designate three free hours per week for entry to the Japanese Tea
6 Garden.

7 **(b)(d)** The Recreation and Park Commission is authorized to establish a program
8 offering a 50 percent reduction of fees to the Japanese Tea Garden for the first Wednesday of each
9 month for up to nine months of the year. programs offering:

10 **(1)** Bulk purchase admission tickets for groups of over 20 people at a discount of no more
11 than 50 cents from the standard individual admission fee;

12 **(2)** Special time-limited promotions to change admission fees (including, but not limited to,
13 joint marketing promotions, coupons, free hours or days). Promotional discounts will be limited to the
14 equivalent of 20,000 full price admissions annually.

15 **(3)** The Department will report within 90 days of the end of any promotion, or annually for
16 ongoing promotions, to the Recreation and Park Commission of the efficacy of any promotion in
17 increasing visitation and the impact on revenues to the Department.

18 **(e)(e)** The following fees shall be charged for weddings in the Japanese Tea Garden:

19 First two hours: \$500.00

20 Each additional hour: \$100.00


