7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the action entitled "Trapalis-
9 Baird v. City and County of San Francisco, et al.", San Francisco Superior Court, Case No.
10 419634, by payment of \$285,000. The sum shall be allocated as follows: a) \$184,692.39 for
11 general damages including emotional distress; and b) \$100,307.61 for attorney's fees and
12 costs of suit.

13 Section 2. The above-named action was filed in San Francisco Superior Court on April
14 22, 2002, Case No. 419634. The following parties were named in the lawsuit: Maria Trapalis-
15 Baird, plaintiff; City and County of San Francisco, defendant.

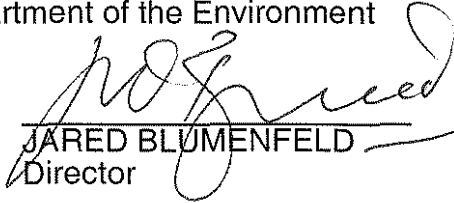
