8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Dante King v. City and County of San  
11 Francisco, San Francisco Superior Court, Case No. CGC-22-601923 by the payment of  
12 \$562,500. The lawsuit involves an employment dispute.
