

5 represents more than half of San Francisco’s registered voters; now, therefore, be it

6 RESOLVED, That the San Francisco Board of Supervisors considers the United States
7 Postal Service an essential piece of our election infrastructure and consider any deliberate
8 attempt to impede the function of the United States Postal Service to be an attempt to
9 undermine democracy; and, be it

10 FURTHER RESOLVED, That the San Francisco Board of Supervisors urges the United
11 States Congress to provide urgent funding to the United States Postal Service in light of the
12 coronavirus pandemic and due to an expected surge in mail ahead of this November’s
13 election; and, be it

14 FURTHER RESOLVED, That the San Francisco Board of Supervisors urges the United
15 States Postal Service to continue applying First Class mail standards to all election mail; and,
16 be it

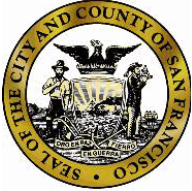
17 FURTHER RESOLVED, That the San Francisco Board of Supervisors urges the United
18 States Postal Service to postpone any decommissioning of mail sorting machines at the
19 San Francisco Processing and Distribution Center and throughout the country; and, be it

21 States Postal Service to halt removal of all letter collection boxes; and, be it

22 FURTHER RESOLVED, That the San Francisco Board of Supervisors recognizes that

24 services and standards, ahead of this November’s election, is equivalent to voter suppression;
25 and, be it
