2 OPPOSING THE REQUEST FOR THE ISSUANCE OF A TYPE 48 ON-SALE GENERAL PUBLIC PREMISES
3 ALCOHOLIC BEVERAGE CONTROL LICENSE TO JOHN R. DIDOMENICO IN EXCHANGE FOR A TYPE
4 42 LICENSE FOR NICKIE'S HAIGHT STREET BBQ, LLC, LOCATED AT 460 HAIGHT STREET, WILL NOT
5 SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE CITY AND COUNTY

9 WHEREAS, John R. Didomenico is seeking the issuance of a of a Type 48 on-sale general public
10 premises alcoholic beverage control license in exchange for a Type 42 license at Nickie's Haight Street BBQ, LLC,
11 located at 460 Haight Street; and,

12 WHEREAS, At the Small Business, Economic Vitality and Consumer Services Committee meeting of May
13 20, 1999, residents of the area testified against the exchange of a liquor license at this location; and,

14 WHEREAS, The Police Department reports the area has an undue concentration of licensed premises and
15 has a high crime rate; and

16 WHEREAS, The Police Department recommends that the liquor license application be denied; now,
17 therefore, be it

18 RESOLVED, That the Board of Supervisors opposes the exchange of a Type 48 on-sale general public
19 premises alcoholic beverage control license for a Type 42 to John R. Didomenico for Nickie's Haight Street BBQ,
20 LLC, located at 460 Haight Street, and determines that it will not serve the public convenience and necessity of the
21 people of the City and County of San Francisco, in accordance with Section 23958.4 of the California Business and
22 Professions Code; and be it

23 FURTHER RESOLVED, That the Board of Supervisors respectfully requests that the Department of
24 Alcoholic Beverage Control deny this application.




