5 \$14,500,000; the lawsuit was filed on November 26, 2016, in San Francisco Superior  
6 Court, Case No. CGC-16-555523; entitled Cui Ying Zhou, et al. v. City and County of San  
7 Francisco, et al.; the lawsuit involves an alleged personal injury in Washington Square  
8 Park.**

9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes  
11 the City Attorney to settle the action entitled Cui Ying Zhou, et al. v. City and County of San  
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-16-555523 by the payment of  
13 \$14,500,000. The lawsuit involves an alleged personal injury in Washington Square Park.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 November 26, 2016, and the following parties were named in the lawsuit: Cui Ying Zhou, Jian  
16 Cong Tan, Angelina Tan, and Arosia Tan, Plaintiffs; City and County of San Francisco and  
17 Hortscience, Inc., Defendants.
