14 zoned; and recommends approval, and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED, That in accordance with Section 23958.4 of the California Business**  
18 **and Professions Code, the Board of Supervisors of the City and County of San**  
19 **Francisco hereby determines for the foregoing reasons that the transfer of a Type 48**  
20 **on-sale general public premises license from 536 Golden Gate Avenue to 550-15<sup>th</sup>**  
21 **Street (District 6) to Peter Glikshtern, dba "Five50 Inc.", will serve the public**  
22 **convenience and necessity of the people of the City and County of San Francisco.**

23 **Conditions: 1) The sale and service of alcoholic beverages shall be permitted**  
24 **only between the hours of 11:00 a.m. and 2:00 a.m. each day of the week; 2) Petitioner**  
25 **shall regularly police the area under their control in an effort to prevent the loitering of**

1 persons about the premises; 3) The petitioner shall be responsible for maintaining free  
2 of litter the area adjacent to the premises over which they have control.


