11	Section 1. The San Francisco Administrative Code is hereby amended by adding a			
12	new Article II to Chapter 20, to read as follows:			
13	Article II - Preservation of Emergency Nature of Shelter and Prevention of Loss of			
14	Shelter Bed Based Solely on Lack of Income			
15	Sec. 20.40. FINDINGS. The Board of Supervisors finds and declares the following:			
16	(a) Due to the shortage of affordable housing in San Francisco, many people suffer			
17	from a lack of permanent housing and seek emergency shelter services on a temporary basis			
18	<u>and</u>			
19	(b) Emergency shelter services in San Francisco are a limited resource and should			
20	be preserved for individuals that lack permanent housing and who currently face a housing			
21	crisis; and			
22	(c) Shelter services provided by the City should not be used as a long-term or			
23	permanent solution to homelessness.			
24	Section 20.41. DEFINITIONS. For the purposes of this Chapter, the following			
25	definitions shall apply to the terms used herein.			

1	(a) "Shelter" or "Shelter services" means any shelter provided by the City that offers			
2	temporary, overnight sleeping space on a short-term basis.			
3	(b) "Emergency" means an immediate and urgent need for assistance or relief, or a			
4	time of crisis that requires immediate action.			
5	(c) "Entities that refer individuals to shelter" means any government agency or			
6	community based organization that contracts with the City to provide shelter services,			
7	including but not limited to non-profit organizations and religious institutions, that refer			
8	individuals for emergency shelter or shelter services.			
9	Section 20.42. Preservation of Emergency Nature of Shelter. Individuals that access			
10	the City's shelters and entities that refer individuals to shelter shall only utilize the shelter			
11	system in emergency situations and shall preserve shelter beds for individuals that face an			
12	immediate and urgent shelter need, thereby preserving the emergency nature of the shelter			
13	<u>system.</u>			
14	Section 20.43. No Displacement Based on Income. Under this Chapter, any individua			
15	using an emergency shelter bed shall not be displaced from a shelter bed based solely on a			
16	lack of income.			
17	Section 20.44. SEVERABILITY. If any section, subsection, clause, phrase or portion			
18	of this Chapter is for any reason held invalid or unconstitutional by any court or federal or			
19	State agency of competent jurisdiction, such portion shall be deemed a separate, distinct and			
20	independent provision and such holding shall not affect the validity of the remaining portions			
21	thereof.
