

1 [Resolution encouraging candidates for the Board of Directors of the proposed San Francisco-
2 Brisbane Municipal Utility District to accept voluntary campaign contribution limits.]

3 **Resolution urging candidates for the Board of Directors of the proposed San**
4 **Francisco-Brisbane Municipal Utility District to adopt voluntary campaign contribution**
5 **limits in the November 2001 election.**

7 WHEREAS, Campaign contribution limits for candidates for public office limit the
8 apparent and actual influence of special interests over public officials; and,

9 WHEREAS, The voters of the State of California and the City and County of San
10 Francisco have elected to impose campaign contribution limits on candidates for public office
11 to limit improper influence or the appearance thereof; and,

12 WHEREAS, The voters of San Francisco determined that a \$500 per donor limit is a
13 reasonable limit for candidates for City elective office and imposed that limit on candidates for
14 City elective office in San Francisco Campaign and Governmental Conduct Code Section
15 1.114; and,

16 WHEREAS, Members of the Board of Directors of a Municipal Utility District would also
17 be officials elected to represent the local community; and,

18 WHEREAS, If a Municipal Utility District is created, residents of the district will be best
19 served if their candidates for the Board of Directors agree to abide by reasonable contribution
20 limits consistent with those adopted for other local public officials; now, therefore, be it

21 **RESOLVED**, That the Board of Supervisors strongly urges every candidate for the
22 Board of Directors of the proposed San Francisco-Brisbane Municipal Utility District to
23 voluntarily accept the contribution limits adopted by the voters of San Francisco for City
24 elected officials in San Francisco Campaign and Governmental Conduct Code Section 1.114;
25 and, be it

1 FURTHER RESOLVED, That the Board of Supervisors strongly urges every candidate
2 for the Board of Directors of the proposed Municipal Utility District to sign the campaign
3 contribution pledge form on file with the Clerk of the Board of Supervisors in File
4 No. 011029, which is hereby declared to be a part of this resolution as if set forth
5 fully herein; and, be it

6 FURTHER RESOLVED, That all pledge forms signed by candidates for the Board of
7 Directors shall be filed with and made available to the public for inspection upon request in the
8 office of the Clerk of the Board of Supervisors and the office of the San Francisco Department
9 of Elections.




