3 **Resolution concurring with the Controller's certification that services can be performed**
4 **by private contractor for a lower cost than similar work performed by City and County**
5 **employees for security services for the Asian Art Museum and the Fine Arts Museum.**

7 WHEREAS, The Electorate of the City and County of San Francisco passed Proposition
8 J in November 1976, allowing City and County Departments to contract with private companies
9 for specific services which can be performed for a lower cost than similar work by City and
10 County employees (Charter Section 10.104.15); and,

11 WHEREAS, The Controller has determined that the award of a contract for the services
12 listed below to a private contractor will achieve substantial cost savings for the City; and,

13 WHEREAS, The City and County of San Francisco must reconcile a projected \$483
14 million budget deficit for Fiscal Year 2010-2011 with a Charter obligation to enact a balanced
15 budget each fiscal year; and,

16 WHEREAS, The Mayor has determined that the state of the City's budget for Fiscal Year
17 2010-2011 as indicated herein has created an emergency situation justifying a Purchaser's
18 award of a contract for security services for the Asian Art Museum and the Fine Arts Museum;
19 and,

20 WHEREAS, The Controller's certification, which confirms that said services can be
21 performed at lower costs to the City and County by private contractor than by employees of the
22 City and County, is on file with the Clerk of the Board of Supervisors in File No. 100730, which
23 is hereby declared to be part of this resolution as if set forth fully herein; now, therefore, be it

24 **RESOLVED**, That the Board of Supervisors hereby concurs with the Controller's
25 certification, and the Mayor's determination of an emergency situation, and approves the

RE: Contracting for Museum Security - FY 2010-11

Dear Mr. Buchanan and Mr. Xu:

The cost information and supplemental data provided by your offices on the proposed contract for museum security services have been reviewed by my staff.

If these services are provided at the proposed contract price, it appears they can be performed at a lower cost than if the work were performed by City employees.


The requirements of Charter Section 10.104.15 relative to the Controller's findings that "work or services can be practically performed under private contract at a lesser cost than similar work performed by employees of the City and County of San Francisco" have been satisfied. Attached is a statement of projected cost and estimated savings for Fiscal Year 2010-11 and the informational items provided by the department pursuant to San Francisco Administrative Code Section 2.15.

Your departments do not need to take further action for Board of Supervisors' approval because this determination will become part of the FY 2010-11 budgetary approval process. Following that legislative approval, we will notify your departments and the Purchaser that this Charter requirement has been met.

If it is the departments' intention to enter into a multiple year contract, you should note that this Charter section requires annual determination by the Controller and resolution by the Board of Supervisors.

Contract Services: Museum Security Services

1. The department's basis for proposing the Prop J certification.

To meet the Mayor's targeted budget reduction of General Fund support to the Fine Arts Museums.

2. A. The impact, if any, the contract will have on the provision of services covered by the contract, including a comparison of specific levels of service, in measurable units where applicable, between the current level of service and those proposed under the contract.

We believe that the contract will have minimal impact on the provision of services. We expect the contracted services to provide security coverage and an equal level and depth at significantly lower cost. We expect many of the security guards currently working for the City at the Fine Arts Museums to be hired by the contractor.

- B. For contract renewals, a comparison shall be provided between the level of service in the most recent year the service was provided by City employees and the most recent year the service was provided by the contractor.

The Director of Security as well as the Director of Operations will be responsible for overseeing the vendor as well as the contract and reporting.

4. The contractor's proposed or, for contract renewals, current wages and benefits for employees covered under the contract, and the contractor's current labor agreements for employees providing the services covered by the contract;

The Museums will only approach vendors that are union shops.

5. We believe that the contract will have minimum impact on the provision of services. The security function will continue to be under the oversight of the Museum's Chief Operating Officer.

No contractor agreement exists as of yet. The exact terms of the contract remain to be explored and negotiated with an appropriate vendor. The Prop J savings are estimates based on Asian Art Museum staffing and service levels costed out at fully loaded salary and benefit rates for similar services provided by a union contractor at an independent SF museum.

Comments/Assumptions:

1. FY 2010-11 would be the first year these services are contracted out.
2. Salary levels reflect proposed salary rates effective July 1, 2010. Costs are represented as annual 12 month costs.
3. Variable fringe benefits consist of Social Security, Medicare, employer retirement costs, employee retirement pick-up, and long-term disability, where applicable.
4. Fixed fringe benefits consist of health and dental rates plus an estimate of dependent coverage.
5. The estimated City costs exclude materials, supplies, and uniforms; if included these costs would increase the estimated savings to CCSF.
6. Estimated contract cost calculated by multiplying current staffing hours by private hourly wage rate. Privatized hourly rates (\$18-\$22/hr + 20% benefits) are based on estimates from three private security companies. Estimated contract cost also includes 0.5 FTE for contract monitoring.
