

The purpose of this letter is to respectfully request VBC SF LLC, doing business as the Vita Brevis Club ("Licensee") be placed on the Board's Calendar for Public Convenience and Necessity ("PCN") approval for the issuance of a California Department of Alcoholic Beverage Control ("ABC") Type 48 liquor license (the "License") at 969 Market Street (the "Premises").

The Licensee acquired the License, which was previously located at 5051 Mission Street, San Francisco, with the intention of transferring the License to the Premises for the purpose of operating a cocktail lounge with an art gallery theme that will feature emerging local artists. The Premises, which was most recently an art gallery, had been vacant throughout the majority of the pandemic.

The issuance of the License at the Premises will serve a public convenience and necessity to San Francisco, and especially the Mid-Market Street area, because it will not only activate an underutilized space on the Market Street corridor, but the business will generate much needed job opportunities for the service industry and will also promote local up and coming artists. By operating during evening hours, the issuance of the License will provide some much needed storefront activation during nonbusiness hours on the Market Street corridor.
