3 **Resolution authorizing the Sheriff's Department to accept and expend a grant in the**
4 **amount of \$93,666 from the Private Industry Council of San Francisco for providing**
5 **employment and education services to young offenders in the county jail and after**
6 **their release.**

7 WHEREAS, The Private Industry Council of San Francisco has made available funding
8 for youth programs; and,

9 WHEREAS, Due to the need for education and job development among young
10 offenders, the Sheriff's Department will provide a program to support academic, vocational,
11 and personal development for young offenders while in custody and after their release; and,

12 WHEREAS, The grant does not require matching funds; and,

13 WHEREAS, The Sheriff's Department proposes to maximize use of available grant
14 funds on program expenditures by not including indirect costs in the grant budget; now,
15 therefore, be it

16 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
17 the grant budget; and be it


18 FURTHER RESOLVED, That a grant award notification has been received from the
19 Private Industry Council of San Francisco; and, be it

20 FURTHER RESOLVED, That the grant provides for the creation of a part-time position
21 as follows: 0.05 FTE Principal Administrative Analyst at a salary of \$172 bi-weekly plus
22 benefits; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
24 Francisco authorizes the Sheriff's Department to accept and expend \$93,666 in grant funds
25 from the Private Industry Council of San Francisco; and be it


1 FURTHER RESOLVED, That the City and County of San Francisco will adhere to the


