WHEREAS, The Department of Public Health's OMI Family Center provides valuable mental health services to the residents of the Ocean, Merced, Ingleside neighborhoods; and

WHEREAS, The Real Estate Division has negotiated a lease to meet the needs of the OMI Family Center on file with the Clerk of the Board of Supervisors in File No. , which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, The term of the lease shall be for 10 years with an estimated commencement date of February 20, 2007, following the completion of the required leasehold improvements; and,

WHEREAS, The City shall have two (2) additional option periods to renew the lease of five (5) years each; and,

WHEREAS, The base monthly rent shall be \$13,150 fully serviced subject to a Consumer Price Index adjustment in the fifth year of no less than 15% nor more than 30%

WHEREAS, The Landlord will provide \$200,000 of leasehold improvements and the City shall pay Landlord the verified costs in excess of the \$200,000 totaling \$486,262; now, therefore, be it

RESOLVED, That in accordance with the recommendation of the Director of the Department of Public Health and the Director of Property, the Director of Property is hereby authorized to take all actions, on behalf of the City and County of San Francisco, as Tenant, to execute the Lease with Huey Lan F. 2004 Trust, as Landlord for 1701 Ocean Avenue, San

Francisco, California, on file with the Clerk of the Board of Supervisors in File No. which is hereby declared to be a part of this resolution as if set forth fully herein; and, be it

FURTHER RESOLVED, That the monthly base rent shall be \$13,150 upon occupancy (2.63 per square foot) fully serviced, subject to a Consumer Price Index adjustment in the fifth year of no less than 15% nor more than 30%.

FURTHER RESOLVED, That the City will pay the verified leasehold improvement costs in excess of \$200,000 totaling \$486,262; and, be it

FURTHER RESOLVED, That the City shall have two (2) additional option terms of five years each; and be it

FURTHER RESOLVED, That the Lease shall include a clause approved by the City Attorney, indemnifying and holding harmless the Landlord from and agreeing to defend the Landlord against any and all claims, costs and expenses, including, without limitation, reasonable attorney's fees, incurred as a result of Cy's sue of the premises, any default by the City in the performance of any of its obligations under the lease or any acts or omissions of City or its agents, in, on or about the premises or the property on which the premises are located, excluding those claims, costs and expenses incurred as a result of the active gross negligence or willful misconduct of Landlord or its agents; and be it

FURTHER RESOLVED, That all actions heretofore taken by the officers of the City with respect to such lease are hereby approved, confirmed and ratified; and be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Property to enter into any amendments or modifications to the lease that the Director of Property determines, in consultation with the City Attorney, are in the best interest of the City, do not increase the rent or otherwise materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the lease and are in compliance with all applicable laws, including City's Charter.
