[Building Code - Building Permit Expiration Timelines]

**Ordinance amending the Building Code to revise the timing of expiration of certain building permits and building permit applications; and affirming the Planning Department's determination under the California Environmental Quality Act.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. General Findings.

(a) The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 250811 and is incorporated herein by reference. The Board affirms this determination.

(b) On October 16, 2025, the Building Inspection Commission considered this ordinance at a duly noticed public hearing pursuant to Charter Section 4.121 and Building Code Section 104A.2.11.1.1.

(c) No local findings are required under California Health and Safety Code Section 17958.7 because the amendments to the Building Code contained in this ordinance do not regulate materials or manner of construction or repair and therefore do not modify building standards. Even if the amendments are considered modifications to building standards, the

1 amendments to building permit expiration timelines are not new, local building standards  
2 because they largely revert to or conform with the underlying provisions of the California  
3 Building Code. All amendments are consistent with the intent of recently enacted Assembly  
4 Bill 130, which is intended to prohibit local building standards applicable to residential units  
5 that are more restrictive than the California Building Code, and are also permissible because  
6 they would result in reductions in operating costs for the Department of Building Inspection.  
7 (Health & Safety Code § 17958.5(c)(6)(D)).

8  
9 Section 2. Chapter 1A of the Building Code, Section 106A is hereby amended by  
10 revising Sections 106A.3.4, 106A.3.7, and 106A.4.4, to read as follows:

11  
12 **106A.3.4 General Permit Procedures.**

13 \* \* \* \*

14 **106A.3.4.2.3 Addenda to site permits.** The site permit must be issued prior to  
15 submittal of the first addendum. Plans for construction may be divided and submitted in  
16 accordance with an addenda schedule submitted on the site permit drawings or on the first  
17 addendum drawings. See Section 110A<sub>1</sub>, Table 1A-B – Other Building Permit and Plan  
18 Review Fees – for applicable fee.

19 The holder of such permit and addenda shall proceed with approved addenda work  
20 at the permittee's own risk, without assurance that approvals for the remaining addenda or for  
21 the entire building or structure will be granted.

22 Each addendum must be approved and issued before work shown on that addendum  
23 may commence. The time allowed for review, approval, and issuance of all addenda is  
24 governed by the maximum time allowed under Section 106A.4.4 ~~and Table B – Maximum Time~~  
25 ~~Allowed to Complete All Work Authorized by Building Permit.~~ The extension times may be applied

upon payment of a fee per Section 110A, Table 1A-J – Miscellaneous Fees. If all required addenda are not approved and issued by the maximum time allowed, the site permit, all previously approved addenda, and all remaining addenda shall be deemed to be canceled. When a site permit has been canceled, an alteration work application shall be required to resume processing. The provisions of Section 107A.3.3 shall apply to such alteration work application.

\* \* \* \*

**106A.3.7 Application expiration.** The Building Official may hold in abeyance or reject any application, plans, or specifications filed which in the Building Official’s opinion, do not provide the necessary information in a clear and concise manner as required in Section 106A.3.3. An application for a permit for any proposed work shall be deemed to have been abandoned, and shall expire, 730 days after the date of filing if no permit has been issued, except that the Building Official may grant one or more extensions of time for additional periods not exceeding 180 days each. Such extension shall be requested in writing and shall demonstrate justifiable cause for the extension, and shall cancel such an application 365 days after submittal ~~upon the expiration of the time period set forth per Table A.~~

~~At the time the application has been deemed acceptable for building plan review by the Department of Building Inspection, any corrections, additional information, plans, or documents that are necessary to complete the processing by the Department of Building Inspection shall be submitted and approved within 365 days.~~ *the following time limitations:*

2       The 365-day time limitation shall apply until the application has been approved and  
3 permit is issued. A one-time extension of 180 days ~~per Table A~~ may be granted by the Building  
4 Official at any point during the approval process, upon written request by the applicant and  
5 payment of fee. Additional extensions may be granted by the Building Official prior to  
6 extension expiration upon written request from the applicant and payment of fee. See Section  
7 110A, Table 1A-J – Miscellaneous Fees – for applicable fee for such extensions. In the event  
8 an extension of time extends the life of an application beyond the effective date of the  
9 adoption of a new code, the Building Official may require that all or part of the application be  
10 subject to the provisions of the new code and payment of an additional plan review fee per  
11 Table 1A-A—Building Permit Fees. In the event the application has not been approved and  
12 issued within 60 days before the end of the ~~stated~~ time periods set forth in this Section 106A.3.7  
13 ~~in Table A~~, the Department shall notify the applicant that the application will be canceled in 60  
14 days unless the application is extended. An application which exceeds the stated or extended  
15 time period after such notice shall be deemed canceled without further action by the  
16 Department.

17       **EXCEPTIONS:**

18       1.—For applications resulting from enforcement actions initiated by the Building  
19 Official to abate code violations, the above time limits shall be reduced to 30 days and 10  
20 days, respectively. The Building Official may grant an extension for hardship or procedural  
21 error. Upon cancellation, such cases shall be referred to the City Attorney for legal action.

22       —2.—The above time limits shall not apply to applications which are subject to the work  
23 without permit investigation fee per Section 110A, Table 1A-K—Penalties, Hearings, Code  
24 Enforcement Assessments. Such applications shall be canceled only through specific action  
25 by the Building Official.

1           —3. The above time limits shall be suspended whenever an application is returned to  
2 the Planning Department for review due to a design change that the Building Code(s)  
3 requires.

5           **106A.4.4 Permit expiration.** Every permit issued by the Building Official under the  
6 provisions of this code, ~~including any site permit or site permit addendum unless an extension of time~~  
7 ~~has been specifically approved by the Building Official, shall be valid from the date of issuance,~~  
8 ~~provided that any permit shall expire and become null and void 365 days from date of issuance if the~~  
9 ~~work authorized under any permit associated with the current scope of work has not been commenced;~~  
10 ~~or shall expire and become null and void whenever the Department determines that the work~~  
11 ~~authorized by any permit has been suspended, discontinued, or abandoned for a continuous period of~~

12 applications involving compliance actions initiated by the Department, in a manner other than

14 that due process is assured all applicants. In this regard, the Building Official may reduce the  
15 time periods set forth in this section as they apply to a second application and permit required  
16 by the Building Official to effect full compliance with this code and other applicable laws and  
17 regulations if by doing so code compliance would be more expeditiously accomplished.

18 ~~3. EXCEPTION:~~ In order to avoid repetitive filings and processing of applications  
19 to effect code compliance, the Building Official is hereby authorized to establish alternate  
20 procedures and extensions of time from cancellation pursuant to Section ~~106A.106A~~.4.1 and  
21 from expiration pursuant to this section; provided, however, that the Building Official, in  
22 establishing alternate procedures and extension of time, shall proceed as expeditiously as  
23 possible toward abatement of the violations.

24 When a permit is issued but delayed due to actions before the Board of Appeals or  
25 other City agencies, or cases in any court of competent jurisdiction, or is under review by a

State or regional regulatory body, the time allowable shall be computed from the date of the final action of the agency or court of jurisdiction.

Section 3. Effective Date. This ordinance shall become effective 180 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor’s veto of the ordinance.

Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment

**REVISED LEGISLATIVE DIGEST**  
*(Amended in Committee – November 17, 2025)*

[Building Code - Building Permit Expiration Timelines]

**Ordinance amending the Building Code to revise the timing of expiration of certain building permits and building permit applications; and affirming the Planning Department's determination under the California Environmental Quality Act.**

Existing Law

Building Code Section 106A.3 sets forth the timing for expiration of any permit application submitted to the Department of Building Inspection, which is either 360 calendar days or 720 calendar days from the time of submittal, depending on the value of the work authorized. Extensions of an additional 360 calendar days or 720 calendar days are also permitted. The Code provides certain exceptions to these timelines. The Code also provides that if an extension extends the life of an application beyond the effective date of the adoption of a new Building Code, the Building Official may require that all or part of the application be subject to the provisions of the new Code.

Building Code Section 106A.4 sets forth the timing for expiration of any permits issued by the Building Official, which ranges from 360 days to 1,440 days, depending on the value of the work authorized. Extensions of up to 720 days are permitted.

Amendments to Current Law

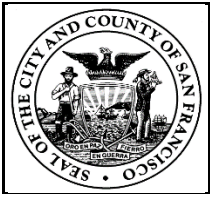
This ordinance would amend Building Code Section 106A.3 so that any application submitted to the Department shall expire within 730 days of submittal, and the Building Official may grant extensions of 180 days upon showing of justifiable cause. This ordinance would remove the Building Official's authority to require that an application be subject to the provisions of a new Building Code if an extension extends the life of the application beyond the effective date of the adoption of a new Building Code. This ordinance would also remove certain exceptions to this building permit application expiration deadline (for applications related to enforcement actions initiated by the Building Official and applications related to investigations of work without permits).

This ordinance would amend Building Code Section 106A.4 so that any permit issued by the Department shall expire 365 days from date of issuance if the work authorized has not commenced; or shall expire whenever the Department determines that the work authorized has been suspended, discontinued, or abandoned for a continuous period of 365 days. This ordinance would permit one extension of 180 days.

The Code Advisory Committee met on October 8, 2025 to consider adoption of File No. 250811 amending the Building Permit & Application Expiration Timelines, including amendments proposed by the Department and sponsor. The CAC proposed additional language to clarify that application extensions "will not be unreasonably withheld." The committee voted unanimously to recommend the Building Inspection Commission approve File No. 250811.

The Building Inspection Commission met and held a public hearing on October 16, 2025 regarding the proposed amendment to the Building Code contained in Board File No. 250811.

The Commissioners voted unanimously to **recommend approval of the Ordinance including amendments proposed by the Department and sponsor.**

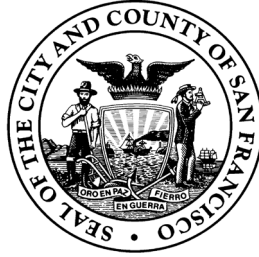
