2 **Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to accept and**
3 **expend a grant in the amount of \$400,000 from the Department of Justice (DOJ), Office**
4 **of Violence Against Women (OVW), FY2007 Safe Havens: Supervised Visitation and**
5 **Safe Exchange Program for the purpose of supporting supervised visitation and safe**
6 **exchange options for families with a history ^{of} violence or abuse.**

7 WHEREAS, MOCJ is the lead fiscal agency in administering the Safe Havens:
8 Supervised Visitation and Safe Exchange Program; and

9 WHEREAS, San Francisco applied and was awarded on September 13, 2007, four
10 hundred thousand dollars (\$400,000); and

11 WHEREAS, Rally Family Visitation Services of Saint Francis Memorial Hospital, the
12 San Francisco Unified Family Court, La Casa de las Madres, Department on the Status of
13 Women and the Department of Children, Youth and Families' Safe Start Initiative will be
14 responsible for coordination and day-to-day operations of the planning and implementation
15 phases of this grant; and

16 WHEREAS, MOCJ will be responsible for the fiscal, programmatic and administrative
17 reporting to OVW; now, therefore, be it

18 RESOLVED, That the City and County of San Francisco hereby authorizes MOCJ to
19 accept and expend \$400,000 from the Office of Violence Against Women, to administer the
20 Safe Havens: Supervised Visitation and Safe Exchange Program; and

21 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now
22 therefore, be it


23 FURTHER RESOLVED, That the City and County of San Francisco hereby waives






