13 WHEREAS, Dr. Lee was fired from his job on March 8, 1999, due to  
14 the allegations that he is a spy; and,

15 WHEREAS, The media through its coverage has charged, tried and  
16 convicted Dr. Lee; and,

17 WHEREAS, There has not been an investigation into the  
18 allegations; therefore, be it

19 RESOLVED, That the San Francisco Board of Supervisors urges  
20 United States Attorney General Janet Reno, the United States Justice  
21 Department and United States Energy Secretary Bill Richardson to  
22 immediately launch a fair, impartial investigation to find the truth  
23 about Dr. Wen Ho Lee; and, be it


