1 [Revising Board of Appeals Surcharges.]

3 **Ordinance amending Section 10G.1 of the San Francisco Administrative Code to adjust**
4 **the surcharges on permit fees, license fees, permit review fees and permit and license**
5 **renewal fees imposed by the Department of Building Inspection, the Planning**
6 **Commission, the Taxi Commission, the Police Department, the Department of Public**
7 **Works, the Entertainment Commission, and the Department of Public Health for**
8 **permits and licenses that may be appealed to the Board of Appeals, and making**
9 **environmental findings.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The San Francisco Administrative Code is hereby amended by amending
15 Section 10G.1, to read as follows:

16 **SEC. 10G.1. SURCHARGE IMPOSED; CATEGORIES OF PERMITS AND FEES.**

17 In order to recover the cost to the City and County for the Board of Appeals permit
18 review functions, at the time a fee for permit application, issuance, or review is collected, and
19 at the time an annual fee for renewal of the permit or license associated with the permit is
20 collected, a surcharge in the amount specified shall be charged and collected for the following
21 categories of permits and fees.

22 (a) For fees imposed by the Department of City Planning pursuant to San Francisco
23 Planning Code Sections 351(h), 352(a), (except for fees imposed for hearings on Conditional
24 Uses under Section 303 or Planned Unit Developments under Section 304, 353(a), 353(b),

1 353(c), or 355 for review of permits that may be appealed to the Board of Appeals pursuant to
2 Charter Section 4.106, a surcharge of ~~\$13.00~~ \$18.50;

3 (b) For permits issued pursuant to San Francisco Building Code Section 110A:
4 Tables ~~1-A, 1-F, 1A-A, 1A-F, Item 3, 1-H, 1-K, 1A-H, 1A-K, Item 8, or 1-Q, 1A-Q, Item 5~~; that
5 may be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of
6 ~~\$13.00~~ \$18.50;

7 (c) For permits issued pursuant to the San Francisco Public Works Code that may
8 be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$1.00~~
9 \$2.50;

10 (d) For permits specified in San Francisco Police Code Section 2.26 that may be
11 appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$10.00~~
12 \$18.00 for such permits issued by the Police Department, and a surcharge of ~~\$3.00~~ \$5.00 for
13 such permits issued by the Entertainment Commission;

14 (e) For permits specified in San Francisco Police Code Section 2.26.1 that may be
15 appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$3.00~~
16 \$2.50;

17 (f) For annual license fees specified in San Francisco Police Code Section 2.27 for
18 permits that may be appealed to the Board of Appeals pursuant to Charter Section 4.106, a
19 surcharge of ~~\$10.00~~ \$18.00 for such permits issued by the Police Department and a surcharge
20 of ~~\$3.00~~ \$5.00 for such permits issued by the Entertainment Commission;

21 (g) For annual license fees specified in San Francisco Police Code Section 2.27.1
22 for permits that may be appealed to the Board of Appeals pursuant to Charter Section 4.106,
23 a surcharge of ~~\$3.00~~ \$2.50;

1 (h) For permits issued pursuant to San Francisco Health Code Section 1009.53 that
2 may be appealed to the Board of Appeals pursuant to Charter Section 4.106, and annual
3 permit fees pursuant to San Francisco Health Code Section 1009.54 and Business and Tax
4 Regulations Code Section 249.16, a surcharge of ~~\$26.00~~ \$32.00.

5 ~~(i) For permits issued pursuant to San Francisco Health Code Section 3307 that may be~~
6 ~~appealed to the Board of Appeals pursuant to Charter Section 4.106 and San Francisco Health Code~~
7 ~~Section 3317, and annual license fees pursuant to San Francisco Health Code Section 3318 and~~
8 ~~Business and Tax Regulations Code Section 249.20, a surcharge of \$109.00.~~

9 Section 2. The Planning Department has determined that the actions contemplated in
10 this Ordinance are in compliance with the California Environmental Quality Act (California
11 Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk
12 of the Board of Supervisors in File No. _____ and is incorporated herein by this
13 reference.
