15 Director's Office to assist with the reconfiguration of Moscone Center for the 1984 Democratic  
16 National Convention; and

17 WHEREAS, Jill Thompson came to the San Francisco Public Utilities Commission to  
18 serve as Executive Assistant to PUC General Manager Don Birrer; and

19 WHEREAS, Jill Thompson has served with six PUC General Managers; and

20 WHEREAS, In 2000 Jill Thompson was promoted to Public Utilities Commission  
21 Secretary; and

22 WHEREAS, In all her endeavors for the City Jill Thompson exhibited qualities of  
23 character, good will and determination that have made her uncommonly effective; and

24 WHEREAS, Jill Thompson has earned the trust and affection of all who have worked  
25 with her; and
