7 WHEREAS, The Annie E. Casey Foundation has supported San Francisco's efforts to
8 implement the Juvenile Detention Alternatives Initiative (JDAI) Core Principles; and,

9 WHEREAS, The City and County of San Francisco deems it essential to continue the
10 process of Juvenile Justice Reform; and,

11 WHEREAS, A portion of the grant funds will support one existing 1842 Management
12 Assistant position (1.00 FTE) that is currently reflected in the ASO ; and,

13 WHEREAS, The Juvenile Probation Department has been selected to receive an
14 unconditional, unrestricted grant in the amount of \$25,000 from the Annie E. Casey
15 Foundation; now, therefore, be it

16 RESOLVED, That the Juvenile Probation Department of the City and County of San
17 Francisco is authorized to enter into the attached grant award agreement on behalf of the
18 City; and be it

19 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
20 indirect costs in the grant budget; and be it

21 FURTHER RESOLVED, That William P. Siffermann, Chief Probation Officer of the San
22 Francisco Juvenile Probation Department be authorized to accept and expend \$25,000 of the
23 grant funds for the benefit of the San Francisco Juvenile Probation Department; and be it


1 FURTHER RESOLVED, That the City and County of San Francisco will adhere to the


