3 **Resolution declaring February 1 through February 7<sup>th</sup> as Larry Brinkin Week in the City**

6 WHEREAS, Larry Brinkin has worked for over forty years to advance the civil and  
7 human rights of all people, and in particular the rights of Gay, Lesbians, Bisexuals and  
8 Transgender people as a co-founder of Bay Area Gay Liberation, the Lesbian/Gay Labor  
9 Alliance, and the Gay & Lesbian Alternative Dispute Resolution Service , and

10 WHEREAS, Larry Brinkin has served the City and County of San Francisco for twenty-  
11 two years working with the San Francisco Human Rights Commission; and

13 WHEREAS, Larry Brinkin has been a fierce and tireless advocate for the Human  
14 Rights Commission and its constituents, and is someone who is recognized as an invaluable  
15 mediator of community disputes and a resource for underrepresented peoples; and

16 WHEREAS, Larry Brinkin's dedication to advance the civil rights of all people has  
17 never stopped; and

18 WHEREAS, Larry's is joined in life by his loving Husband Wood Massi and his son Ben,
