3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**
4 **and expend retroactively a grant in the amount of \$11,927 from FACET, BAART**
5 **Programs Turk Street Clinic for a project entitled "FACET – SFDPH Nutrition Services,"**
6 **for the period of January 1, 2008 through December 30, 2008.**

8 WHEREAS, FACET, BAART Programs Turk Street Clinic has agreed to fund DPH in
9 the amount of \$11,927 for nutritional services, for the period of January 1, 2008 through
10 December 30, 2008; and,

11 WHEREAS, These funds will allow DPH's Nutritional Services section to provide
12 nutrition services and technical assistance to staff and clients at FACET, BAART Programs
13 Turk Street Clinic for four hours per week; and,

14 WHEREAS, As a condition of receiving the funds FACET, BAART Programs Turk
15 Street Clinic requires DPH to enter into an Memorandum of Understanding (MOU) agreement
16 (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File
17 No. 080228, which is hereby declared to be a part of this resolution as if set forth
18 fully within; and,

19 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
20 for one existing position, Nutritionist (Job Class #2846) at .10 FTE, for the period of January 1,
21 2008 through December 30, 2008; and,

22 WHEREAS, A request for retroactive approval is being sought because the MOU was
23 not obtained by DPH until January 14, 2008; and,

24 WHEREAS, The budget includes a provision for indirect costs of \$1,084; now
25 therefore, be it

7 agreement on behalf of the City; and, be it

8 FURTHER RESOLVED, That the Controller is directed to designate all positions
9 funded under this agreement as "G" or grant-funded positions which would terminate when
10 the agreement expires.


