2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

6 **BICYCLE LANES - ESTABLISH**

7 Laguna Honda Boulevard, northbound, from Clarendon Avenue to approximately
8 750 feet southerly (750-foot zone)

9 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

10 Laguna Honda Boulevard, east side, from approximately 350 feet to 750 feet south
11 of Clarendon Avenue (400-foot zone)

12 Jackson Street, south side, from Stockton Street to 21 feet westerly (21-foot zone)

13 **NO LEFT TURNS, 7 AM - 9 AM AND 4 PM - 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

14 Duboce Avenue, eastbound, at Valencia Street

15 **TOW-AWAY, NO STOPPING, 3 PM - 6 PM, MONDAY THROUGH FRIDAY - RESCIND**

16 Kearny Street, east side, between Jackson and Washington Streets

TOW-AWAY, NO STOPPING, 3 PM - 6 PM, MONDAY THROUGH FRIDAY - RESCIND




