7 WHEREAS, Hollister Avenue is the name of the public right-of-way in this sector of the
8 City; and

9 WHEREAS, Hollister Avenue is where the energetic, selfless, compassionate, and
10 hardworking Bryan Craig Kelley, a 30-year-old, and his family have lived for over four
11 decades; and

12 WHEREAS, Bryan Kelley was a positive and motivating individual with a magnetic
13 personality; and

14 WHEREAS, Bryan Kelley excelled in any area he found of interest; and

15 WHEREAS, Bryan Kelley believed in teamwork, as demonstrated by his
16 compassionate and selfless character while counseling young boys as part of the San
17 Francisco Brown Bombers football program; and

18 WHEREAS, Bryan Kelley embraced leadership roles both at work and at home, always
19 guided by his strong sense of community; and

20 WHEREAS, Bryan Kelley took pride in being a steward for his community; and

21 WHEREAS, Bryan Kelley volunteered at recreation centers and organized coat drives,
22 personally purchasing coats and keeping them in his car to distribute to those in need; and

23 WHEREAS, Bryan Kelley was a law-abiding citizen throughout his life, tragically killed
24 in a case of mistaken identity in a freeway drive-by shooting; now, therefore, be it

1 RESOLVED, That in order to publicly recognize the legacy of Bryan Craig Kelley, there
2 shall be an honorary naming of "Bryan Craig Kelley Way" on Hollister Avenue between
3 Jennings Street and Ingalls Street, to enshrine his legacy and honor his profound impact on
4 the community that helped shape his magnanimous character; and, be it

5 FURTHER RESOLVED, That the Department of Public Works is hereby directed to
6 add the honorary street name to its official list of Commemorative Street Names, in
