18 FURTHER MOVED, That the Redevelopment Agency in its letter dated September 5,
19 2003, stated that the project is in conformance with the Mission Bay North Redevelopment
20 Plan.


21 FURTHER MOVED, That approval of this map is also contingent upon compliance by


