

1 (Lease of Real Property)

2 AUTHORIZING THE LEASE OF REAL PROPERTY AT 1101 CAPP STREET FOR THE  
3 SAN FRANCISCO POLICE DEPARTMENT.

4 RESOLVED, In accordance with the recommendation of the Chief of Police and the  
5 Director of Property that the Mayor and Clerk of the Board of Supervisors, on behalf of the City  
6 and County of San Francisco, as Tenant, be and they are hereby authorized and directed to  
7 execute the lease with Michael and Elizabeth Brosnan and John and Joan Brosnan, as Landlord,  
8 for 1101 Capp Street, San Francisco, California.

9  
10 The term of the lease shall be for five years commencing retroactively on 4/1/2000 and  
11 terminating 3/31/2005 with cancellation rights for the fourth and fifth year. If funds are not  
12 appropriated in any subsequent fiscal year, City may terminate the lease upon 90-day notice to  
13 Landlord.

14  
15 The base monthly rental rate is \$3,272.50. City will be responsible for separately  
16 metered gas and electrical service and janitorial services. Landlord is responsible for water and  
17 debris service.

18 City shall hold Landlord harmless from any claims or liability for any injury or damage  
19 to any person or property occurring in or about the leased premises resulting from the negligence  
20 of City, its agents or employees.


21 Said lease shall be subject to certification by the Controller pursuant to Section 3.105 of  
22 the Charter.

23  
24 The City Attorney shall approve the form of the Lease.




