3 **Resolution designating San Francisco Print Media Co., commonly known as The**
4 **Examiner, and The San Francisco Chronicle to be the official newspapers of the City**
5 **and County of San Francisco for all official advertising for FY2014-2015 and ratifying**
6 **the Office of Contract Administration's extension of the previous advertising contract**
7 **with the San Francisco Chronicle for July 2014.**

9 WHEREAS, In each year, the Board of Supervisors shall designate the official
10 newspaper of the City and County of San Francisco, pursuant to Administrative Code,
11 Sections 2.80-1 and 2.81; and

12 WHEREAS, Based on the anticipated date of approval of this Resolution, and to
13 prevent the interruption of services to City Departments, the Office of Contract Administration
14 has executed a modification to the existing San Francisco Chronicle Agreement; the San
15 Francisco Chronicle Agreement dated January 1, 2014, has been extended by one month, or
16 until this Resolution has been adopted and signed, subject to ratification by the Board; now,
17 therefore, be it

18 RESOLVED, That San Francisco Print Media Co., commonly known as The Examiner,
19 and The San Francisco Chronicle, newspapers of general circulation published in the City and
20 County of San Francisco for the dissemination of local or telegraphic news and intelligence of
21 a general character, having a bona fide circulation of at least 50,000 copies per calendar
22 week, printed in the City, are hereby designated as official newspapers of the City and County
23 of San Francisco for the publication of all official advertising of the City and County for
24 FY2014-2015 starting on the effective date of this Resolution through June 30, 2015; and, be

1 FURTHER RESOLVED, That the Office of Contract Administration is hereby
2 authorized to enter into a contract with San Francisco Print Media Co., commonly known as
3 The Examiner for the period of January 1, 2015, through June 30, 2015, and The San
4 Francisco Chronicle for the period of August 1, 2014, through December 31, 2014, and said
5 contract(s) must be in accordance with all the contracting requirements of the City and County
6 of San Francisco; and, be it

7 FURTHER RESOLVED, That the Board hereby approves and ratifies the modification
8 extending the term of the previous contract with The San Francisco Chronicle as executed by
9 the Office of Contract Administration, copies of which are contained in Board of Supervisor's
10 File No. 140731.
