3 **Motion appointing Charles Siron, Suresh Patel, Bruce Burge, Seth Katzman, Jorge**  
4 **Portillo, Jeff Buckley, Angela Chu, Matthias Mormino and Patrick Flanagan, terms**  
5 **ending December 31, 2012, to the SRO Task Force, residency requirement waived.**

7       MOVED, That the Board of Supervisors of the City and County of San Francisco does  
8 hereby appoint the hereinafter designated persons to serve as members of the SRO Task  
9 Force, pursuant to the provisions of Resolution 459-06 and Resolution 457-09, for the terms  
10 specified:

11       Charles Siron, seat 1, succeeding himself, term expired, must be a SRO tenant, for the  
12 unexpired portion of a three-year term ending December 31, 2012.

13       Suresh Patel, seat 2, succeeding himself, term expired, must be a private SRO  
14 owner/operator, for the unexpired portion of a three-year term ending December 31, 2012.

15       Bruce Burge (residency requirement waived), seat 3, succeeding Dipak Patel, term  
16 expired, must be a private SRO owner/operator, for the unexpired portion of a three-year term  
17 ending December 31, 2012.

18       Seth Katzman, seat 4, succeeding himself, term expired, must be a non-profit SRO  
19 operator/owner, for the unexpired portion of a three-year term ending December 31, 2012.

20       Jorge Portillo, seat 5, succeeding himself, term expired, must be a representative of the  
21 Mission SRO Collaborative, for the unexpired portion of a three-year term ending December  
22 31, 2012.

23       Jeff Buckley, seat 6, succeeding himself, term expired, must be a representative of the  
24 Central City SRO Collaborative, for the unexpired portion of a three-year term ending  
25 December 31, 2012.

1 Angela Chu, seat 7, succeeding herself, term expired, must be a representative of the  
2 Chinatown SRO Collaborative, for the unexpired portion of a three-year term ending  
3 December 31, 2012.

4 Matthias Mormino, seat 8, succeeding himself, term expired, must be a representative  
5 of the Families SRO Collaborative, for the unexpired portion of a three-year term ending  
6 December 31, 2012.

7 Patrick Flanagan, seat 9, new appointment, must be a SRO tenant, for the unexpired  
8 portion of a three-year term ending December 31, 2012.

9 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 10 1. The membership of the SRO Task Force has a goal to be representative of the  
11 diversity of the City and County of San Francisco.
- 12 2. Applicant Bruce Burge, appointee, who is not a resident of San Francisco, is a  
13 person with experience that uniquely qualifies him to serve on the SRO Task Force.
- 14 3. The SRO Task Force has attempted to fill the position, for which Bruce Burge was  
15 nominated, with an individual who is a City resident and who has the specific  
16 experience, skills, and qualifications, but has been unable to do so at this time. The  
17 Rules Committee has certified that Bruce Burge is qualified to serve on the SRO  
18 Task Force.
- 19 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
20 other possible representative, who is a resident of San Francisco and who has the  
21 specific experience, skills, or qualifications possessed by this applicant, and who is  
22 willing to serve on the SRO Task Force at this time; and, be it

23 FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
24 for Bruce Burge, as allowed in cases where no qualified City resident, willing to serve, can be  
25 found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to

boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
