

1 [Administrative Code Revision, Chapter 54]
2 AMENDING CHAPTER 54 OF PART I OF THE SAN FRANCISCO MUNICIPAL CODE
3 (ADMINISTRATIVE CODE), GOVERNING THE SOUTHEAST COMMUNITY FACILITY
4 COMMISSION, BY AMENDING SECTION 54.2 AND REPEALING SECTION 54.5, TO
5 ELIMINATE OUT-DATED AND OBSOLETE PROVISIONS.

6 Note: Additions are underlined; deletions are in ((double parentheses)).

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. Section 54.2 of Chapter 54 of the San Francisco Administrative Code is
9 hereby amended, to read as follows:

10 SEC. 54.2. ESTABLISHMENT OF COMMISSION; APPOINTMENT; TERMS;
11 MEETINGS; COMPENSATION; EXECUTIVE DIRECTOR.

12 (a) There is established a Commission to be known as the Southeast
13 Community Facility Commission consisting of seven members. Commission members shall
14 be appointed by and serve at the pleasure of the Mayor. Unless the Mayor determines that it
15 is otherwise impracticable, persons appointed to serve as members of the Commission shall
16 either reside or work in the Bayview-Hunters Point community, as defined in Section 54.2(b)
17 of this Chapter.

18 (b) For purposes of this Chapter, the Bayview-Hunters Point community is
19 defined as the area south of the southern curb line of Army Street, east of the eastern curb
20 line of the James Lick Freeway (also known as U.S. Route 101), north of the city and county
21 boundary line shared with San Mateo County, and west of San Francisco Bay.

22 (c) ((Appointments of Commission members shall be made not later than 60
23 days after the effective date of this Chapter. Of the members first appointed, three will serve
24 for a term of two years, two will serve for a term of three years, and two will serve for a term of
25 four years. The term of office of each member shall be determined by the drawing of lots at

1 the first meeting of the Commission. Thereafter, m)) Members will be appointed for a term of
2 office of four years, except that all of the vacancies occurring during a term will be filled by an
3 appointment made by the Mayor for the unexpired term. Each vacancy shall be filled within 30
4 days of the occurrence of the vacancy.

5 (d) A president shall be selected by majority vote of the members of the
6 Commission. The president shall serve for a term of two years and shall not serve more than
7 two consecutive terms.

8 (e) The date, place and time of meeting shall be determined by rules adopted
9 by the Commission; provided, however, that the Commission will hold a regular meeting not
10 less than once each month.

11 (f) Subject to the budgetary and fiscal requirements of the Charter, each
12 member shall be paid \$50 per Commission meeting or committee meeting attended. Total
13 compensation shall not exceed \$100 per month.

14 (g) Any member who misses three regularly scheduled meetings of the
15 Commission in any 12-month period without the express approval of the Commission given at
16 a regularly scheduled meeting will be deemed to have resigned from the Commission.

17 (h) The Commission shall appoint an Executive Director, who shall serve at
18 the pleasure of the Commission and shall not be subject to the civil service provisions of the
19 Charter. The Executive Director shall possess the qualifications and experience essential to
20 the administration of the Southeast Community Facility. The Executive Director shall be
21 responsible for the enforcement of the rules and regulations of the Commission and shall
22 manage the daily activities of the Southeast Community Facility not undertaken by lessees.

23 Section 2. Section 54.5 of Chapter 54 of the San Francisco Administrative Code
24 is hereby repealed:



1 The Commission shall issue rules necessary for the conduct of its activities within 180
2 days after the effective date of this Chapter. Proposed rules shall be reviewed by the Director
3 of Public Works and Clean Water Program and the Office of the City Attorney prior to adoption
4 by the Commission.))


