**SUBJECT:** Resolution to approve Peoplesoft Contract ID 1000032407 (TC 86604) for Unarmed Security Guard Services for San Francisco Human Services Agency

Enclosed please find the proposed Resolution from the Office of Contract Administration (OCA), on behalf of the San Francisco Human Services Agency (HSA), requesting that the Board of Supervisors authorize Contract 1000032407 with Good Guard Security, Inc (“Good Guard”) for unarmed security guard services. The proposed contract will have an initial not to-exceed (“NTE”) amount of \$33,760,000 and an initial term of five (5) years, with the option to extend the term for two (2) additional years, for a total contract duration of seven (7) years. The anticipated contract start date is July 1, 2024.

The proposed contract was competitively procured pursuant to Administrative Code 21.2, through a Request for Proposals (RFP) issued by OCA on June 21, 2023 under Sourcing Event 0000008334, as a result of which Good Guard was deemed the highest ranked proposer. The proposed contract will replace HSA’s current Contract 1000010873 with Allied Universal Security Services, Inc. (“Allied Universal”).

**Background**

In 1976, the Electorate of the City and County of San Francisco passed Proposition J allowing City and County departments to contract with private companies for specific services that can be performed for a lower cost than similar work by City and County employees (Charter, Section 10.104.15). Each year, the Board of Supervisors authorizes HSA to contract for private security guard services for its facilities by Board Resolution (“Prop J approval”). The most recent Prop J approval for HSA was obtained under Board Resolution No. 369-23 passed on July 18, 2023. Based on its continuing annual Prop J approval from the Board of Supervisors, HSA currently utilizes private security guards for its thirteen (13) locations, as identified below in Table 1 below.

**Request of Proposals (Sourcing Event 000008334)**

Private security guard services for the HSA locations identified above are currently provided by Allied Universal under Contract 1000010873. This contract, which commenced on July 1, 2018, will expire on June 30, 2024 and cannot be further extended. In anticipation of the expiration date of the existing contract with Allied Universal, OCA issued a Request for Proposals (“RFP”) under Sourcing Event 000008334. The RFP was issued in June 2023 and evaluated Proposers based on the criteria shown in Table 2 below.

In response to Sourcing Event 000008334, OCA received seventeen (17) proposals. Of these, two (2) firms withdrew their proposals and three (3) were deemed non-responsive. The remaining twelve (12) proposals were evaluated by a panel of four (4) City employees from HSA’s Human Resources, Investigations, and Workforce Development divisions, as well as the Department of Homelessness and Supportive Housing. The evaluation process spanned approximately five weeks and, on March 5, 2024, OCA issued a Notice of Intent to Award deeming Good Guard as the highest ranked proposer for Sourcing Event 000008334. A summary of each proposer’s ranking is provided in Table 3 below.

**Proposed Contract 1000032407 Pricing Structure**

The RFP evaluated proposers’ pricing based on the lowest percentage mark up over the fully-loaded Prevailing Wage rate for Security Guards as determined by San Francisco Labor and Employment Code Article 102.11 (formerly, San Francisco Administrative Code Section 21C.11). The fully-loaded Prevailing Wage rate associated with security guard services is based on the employee’s years of service with the employer and the employee’s number of dependents. For 2024, the fully loaded Prevailing Wage rate for security guard services ranges from \$20/hr to \$32.88/hr for straight time, \$30/hr to \$42.88/hr for overtime, and \$40/hr to \$52.88/hr for double overtime.<sup>1</sup> Good Guard’s percentage markup over the fully-loaded Prevailing Wage rate for Contract 1000032407 is provided in Table 4 below.

**Proposed Contract 1000032407 NTE Calculations**

Good Guard is expected to provide approximately 138,710 hours of security guard services per year for HSA under Contract 1000032407. Although the hourly rate charged to City will vary based on the fully-loaded Prevailing Wage rate payable to any single employee based on their years of service and number of dependents, OCA has estimated the hourly rates charged to City under the new contract will not vary significantly from the hourly rates charged to HSA by its current contractor, Allied Universal. As such, the proposed NTE amount of \$33,760,000 for Contract 1000032407 with Good Guard is based on calculations for the maximum term of seven (7) years using Purchase Order encumbrances data associated with HSA's existing Contract 1000010873 with Allied Universal. Consistent with the terms of the RFP, the NTE for Contract 1000032407 with Good Guard can be adjusted should actual spend surpass estimated spend. Table 5 shows how the NTE for Contract ID

**Proposed Contract 1000032407 Funding**

HSA has budgeted \$34,300,000 for Contract ID 1000032407 with Good Guard. The funding sources are as follows:

- San Francisco County general fund: 75%
- State of California general fund: 12%
- Federal programs administered by the Department of Health and Human Services and Department of Agriculture Food and Nutrition Service, including Medical Assistance Program (MAP), Temporary Assistance to Needy Families, State Administrative Matching Grants for Food Stamp Program, Foster Care - Title IV-E, and Adoption Assistance Program - Title IV-E (13%)

**Recommendation**

HSA's mission is to deliver essential services that support and protect people, families, and communities in San Francisco. HSA partners with neighborhood organizations and advocates for public policies to improve well-being and economic opportunity for all San Franciscans. Contract 1000032407 with Good Guard will provide unarmed security guard services for all HSA sites, thereby ensuring the safety of its employees and the members of the public who visit those locations each day. As such, this contract is critical to HSA's operations and continued ability to perform its mission-critical services. A timely approval of this resolution will also allow HSA to provide uninterrupted security guard services at each of its location as those services are transitioned from the current contractor Allied Universal to Good Guard.
