2 \$216,400,000 and Refund of \$495,900 Plus Statutory Interest]

3 **Ordinance authorizing settlement of two related lawsuits filed by CWI 2 San Francisco**
4 **Hotel, L.P. against the City and County of San Francisco concerning the real property**
5 **located at 600 Stockton Street, San Francisco, CA (Assessor's Parcel Block No. 0257,**
6 **Lot No. 012) (the "Subject Property") for a stipulated assessed value of the Subject**
7 **Property of \$216,400,000 as of December 30, 2016, contingent upon the Assessment**
8 **Appeals Board's approval, and a refund of \$495,900, plus statutory interest; the first**
9 **lawsuit was filed on November 26, 2019, in San Francisco Superior Court, Case No.**
10 **CGC-19-581046; entitled CWI 2 San Francisco Hotel, L.P. v. City and County of San**
11 **Francisco; the second lawsuit was filed on June 18, 2020, in San Francisco Superior**
12 **Court, Case No. CGC-20-584883; entitled CWI 2 San Francisco Hotel, L.P. v. City and**
13 **County of San Francisco; the lawsuits involve the assessed value of the Subject**
14 **Property for property tax purposes as of the December 30, 2016, purchase date and a**
15 **transfer tax refund.**

17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
19 authorizes the City Attorney to settle the action entitled CWI 2 San Francisco Hotel, L.P. v.
20 City and County of San Francisco, San Francisco Superior Court, Case No. CGC-20-584883,
21 for a stipulated assessed value of the real property located at 600 Stockton Street, San
22 Francisco, CA (APN 0257-012) of \$216,400,000 as of December 30, 2016, contingent upon
23 the Assessment Appeals Board's approval;

1 Section 2. The action in Section 1 was filed in San Francisco Superior Court on
2 June 18, 2020, and the following parties were named in the lawsuit: CWI 2 San Francisco
3 Hotel, L.P., Plaintiff; and City and County of San Francisco, Defendant.

4 Section 3. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
5 authorizes the City Attorney to settle the action entitled CWI 2 San Francisco Hotel, L.P. v City
6 and County of San Francisco, San Francisco Superior Court, Case No. CGC-19-581046, for
7 the payment of \$495,900, plus statutory interest. The lawsuit involves a transfer tax refund.

8 Section 4. The action in Section 3 was filed in San Francisco Superior Court on
9 November 26, 2019, and the following parties were named in the lawsuit: CWI 2 San
10 Francisco Hotel, L.P., Plaintiff; and City and County of San Francisco, Defendant.
