7 WHEREAS, The Board of Supervisors wishes to authorize the listed Board Member(s)
8 supporting the following ballot measure(s) to prepare and submit a written proponent ballot
9 argument(s) and proponent rebuttal ballot argument(s) for submittal to the Director of
10 Elections:

- 11 ▪ Charter Amendment (First Draft) to amend the Charter of the City and County of
12 San Francisco to provide that appointed members of boards and commissions
13 under the Charter forfeit their offices upon filing a declaration of candidacy for state
14 or local elective office; at an election to be held on June 5, 2018. (Board File No.
15 171306) (Supervisors Peskin; Kim, Safai, Yee)
- 16 ▪ Charter Amendment (Third Draft) to amend the Charter of the City and County of
17 San Francisco to authorize the Public Utilities Commission to issue revenue bonds
18 for power facilities when approved by ordinance receiving a two-thirds vote of the
19 Board of Supervisors, and to clarify the scope of the Commission's bond authority
20 with regard to the City's water and clean water utilities; at an election to be held on

8 prepare and submit arguments, may authorize or assign to any other person(s) under the
9 provisions of Elections Code, Sections 530 and 550(c) and (d), the right to prepare and submit
10 the proponent or opponent's ballot arguments and/or respective rebuttal arguments.
