18 Visitors Bureaus; and,

19 WHEREAS, Dale Hess currently serves on the Board of Directors of the American  
20 Society of Association Executives and;

21 WHEREAS, In 1985 Dale Hess was named Association Executive of the Year by the  
22 Northern California Society of Association Executives and received their first Lifetime  
23 Achievement Award in 1997; and,

1           WHEREAS, Dale Hess currently serves on the Board of Directors of Coming Home, a  
2 San Francisco community-based support organization that provides fiduciary services to the  
3 aged and terminally ill; now, therefore, be it


