RESOLVED, that the Board of Supervisors authorizes the acceptance and expenditure of funds from the Zellerbach Family Fund and the Stuart Foundation in the amounts of \$40,000 and \$110,000 respectively by the Department of Human Services for a consultant contract to begin implementation of a family assessment center during the period of December 1, 1999 to November 30, 2000; and be it


