9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 (a) On January 25, 2007, at a duly noticed public hearing, the Planning Commission  
12 in Resolution No. 17367 found that the proposed amendment to the Article 11 designation of  
13 583-587 Howard Street was consistent with the City’s General Plan and with Planning Code  
14 Section 101.1(b). In addition, the Planning Commission recommended that the Board of  
15 Supervisors adopt the Article 11 designation amendment. A copy of said Resolution is on file  
16 with the Clerk of the Board of Supervisors in File No. 070039 and is incorporated herein by  
17 reference. The Board finds that the proposed amendment to the Article 11 designation is  
18 consistent with the City’s General Plan and with Planning Code Section 101.1(b) for the  
19 reasons set forth in said Resolution.

20 (b) Pursuant to Planning Code Section 302, the Board finds that the proposed  
21 amendment to the Article 11 designation will serve the public necessity, convenience and  
22 welfare for the reasons set forth in Planning Commission Resolution No. 17367, which  
23 reasons are incorporated herein by reference as though fully set forth. A copy of said  
24 Resolution is on file with the Clerk of the Board of Supervisors in File No. 070039.

1 (c) The Planning Department has determined that the actions contemplated in this  
2 Ordinance are in compliance with the California Environmental Quality Act (California Public  
3 Resources Code section 21000 et seq.). Said determination is on file with the Clerk of the  
4 Board of Supervisors in File No. 070039 and is incorporated herein by reference.

5 (d) The Board of Supervisors hereby finds that 583-587 Howard Street (Lot 099 in  
6 Assessor's Block 3736) is located outside of a Conservation District, is at least 40 years old, is  
7 judged to be of Individual Importance, and is rated Very Good in Relationship to the  
8 Environment, and that amending its designation from "Unrated—Category V" to  
9 "Contributory—Category III" will further the purposes of and conform to the standards set forth  
10 in Article 11 of the San Francisco Planning Code.

11 Section 2: Designation. Pursuant to Sections 1102 and 1106 of the Planning Code,  
12 the designation of 583-587 Howard Street (Lot 099 in Assessor's Block 3736) is hereby  
13 changed from "Unrated—Category V" to "Contributory—Category III". Appendix C of Article  
14 11 is hereby amended to include this property. This amendment to the Article 11 designation  
15 were initiated by application of the owner and by Resolution No. 606 of the Landmarks  
16 Preservation Advisory Board on November 15, 2006 and by Resolution No. 17367  
17 of the Planning Commission, which Resolutions are on file with the Clerk of the Board of  
18 Supervisors in File No. 070039 and which Resolutions are incorporated herein by  
19 reference as though fully set forth.

20 Section 3. The properties shall be subject to further controls and procedures pursuant  
21 to the San Francisco Planning Code and Article 11.




