6 **entitled Mary Manning and Richard Manning v. City and County of San Francisco; the**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Mary Manning and Richard Manning v.
12 City and County of San Francisco, San Francisco Superior Court, Case No. CGC-22-599750
13 by the payment of \$299,999. The lawsuit involves an alleged personal injury on a City
14 sidewalk.

15 Section 2. The above-named action was filed in San Francisco Superior Court on May
16 23, 2022, and the following parties were named in the lawsuit: Plaintiffs: Mary Manning and
17 Richard Manning, Defendant: City and County of San Francisco.
