RESOLUTION NO. 926-99

[Continuum of Care Plan—Homeless Board Membership]

AMENDING THE CONTINUUM OF CARE PLAN TO INCREASE THE MEMBERSHIP OF THE LOCAL HOMELESS COORDINATING BOARD FROM 30 TO 34 MEMBERS AND TO PROVIDE FOR A TWENTY-FOUR MONTH TERM OF MEMBERSHIP.

WHEREAS, The Board of Supervisors adopted the Continuum of Care Plan as San Francisco's homeless policy document governing the development of an integrated effective and coordinated system of health care, housing, employment and support services to prevent and reduce homelessness, by Resolution No. 827-97; and,

WHEREAS, A component of the Continuum of Care Plan was the creation of a Local Homeless Coordinating Board (Local Board) to advise City departments, commissions, and the Board of Supervisors on policy decisions and budget allocations consistent with the Plan; and,

WHEREAS, The Local Board has thirty (30) members representing a broad spectrum of the community; and,

WHEREAS, The Local Board determined that their work can more effectively proceed with the addition of eight specific community representatives and the deletion of four specific community representatives; and,

WHEREAS, Resolution No. 827-97 did not provide for a designated term of office; now, therefore, be it

RESOLVED, That membership on the Local Board will be increased by one (1) homeless or formerly homeless single adult, five (5) activists from the neighborhood/community, (1) advocate for the business and labor community, all to be appointed by the Mayor, and by one (1) representative from the Commission on Aging; and, be it

FURTHER RESOLVED, That membership on the Local Board will be decreased by one (1) homeless or formerly homeless head of household, one (1) service provider who focuses on harm reduction, and two (2) at-large seats; and, be it

1 FURTHER RESOLVED, That the membership of the Local Board will broaden one (1) position  
2 to include an advocate for the physically disabled as well as the mentally disabled and one (1) position  
3 to include a service provider who focuses on health services, HIV and harm reduction; and, be it

4 FURTHER RESOLVED, That the term of membership shall be twenty-four (24) months with  
5 members permitted to apply for a second twenty-four (24) month period. The terms shall be staggered,  
6 with half of the current Board seats randomly designated to expire in twelve (12) months, and the other  
7 half of the current Board seats randomly designated to expire in twenty-four (24) months.




