4 **Resolution authorizing the Department of Children, Youth and Their Families to accept**
5 **and expend a grant in the amount of \$853,665 from the United States Department of**
6 **Agriculture for the 2006 Mayor’s Summer Food Service Program and the Afterschool**
7 **Snack Program.**

9 WHEREAS, The United States Department of Agriculture provides funds to the City
10 and County of San Francisco to operate the Summer Food Service Program; and,

11 WHEREAS, The funding will provide children ages 0-18 with free lunches during the
12 summer months from June to August 2006; and,

13 WHEREAS, An average of 5,000 children will be served lunch each day during the
14 summer at approximately 110 sites throughout the City; and,

15 WHEREAS, The United States Department of Agriculture has created a pilot Year-
16 Round Feeding Program to provide reimbursement funding for sponsors to provide
17 afterschool snacks for children; and,

18 WHEREAS, Funding from the Year-Round Feeding Program will enable the City and
19 County of San Francisco’s Afterschool Snack Program to provide children with free snacks
20 through 50 afterschool program sites, providing an average of 1,500 children per day with a
21 nutritious snack during the afterschool hours; and,

22 WHEREAS, The grant terms prohibit indirect costs; now, therefore, be it

23 **RESOLVED**, That the Board of Supervisors hereby waives inclusion of indirect costs in
24 the grant budget; and be it

1 FURTHER RESOLVED, That the City and County of San Francisco hereby authorizes
2 the Department of Children, Youth, & Their Families to apply for, accept and expend funds in
3 the amount of \$853,665 from the United States Department of Agriculture to sponsor the 2006
4 Mayor's Summer Food Service Program and Afterschool Snack Program.
