9 WHEREAS, Mayor Ed Lee's Climate Action Tour and Dialogues provide opportunities
10 for business and environmental leaders and policy makers to discuss the City's environmental
11 goals and objectives and learn from one another; and

12 WHEREAS, The gift budget does not include indirect costs in order to maximize the
13 use of funds for direct services; and

14 WHEREAS, A request for retroactive approval is being sought because the Department
15 of the Environment needed to determine budgetary requirements; and

16 WHEREAS, The gift does not require an Annual Salary Ordinance (ASO) amendment;
17 now, therefore, be it

18 RESOLVED, That the San Francisco Board of Supervisors authorizes the Director of
19 the Department of the Environment to retroactively accept and expend a gift of \$12,500 from
20 Renovate-HERO to sponsor Mayor Ed Lee's Climate Action Tours and Dialogues.
