2 AUTHORIZING A RELEASE OF RESERVES OF FEDERAL REFUGEE FORMULA FUNDS
3 IN THE AMOUNT OF \$334,362 TO THE PRIVATE INDUSTRY COUNCIL OF SAN
4 FRANCISCO, INC. AND AUTHORIZING THE PRIVATE INDUSTRY COUNCIL OF SAN
5 FRANCISCO, INC. TO ACCEPT AND EXPEND, RETROACTIVE TO OCTOBER 1, 1998,
6 \$26,121 OF ADDITIONAL REFUGEE FORMULA FUNDS AND \$175,614 OF TARGETED
7 ASSISTANCE DISCRETIONARY FUNDS IN LINE WITH THE REFUGEE COUNTY PLAN.

8 WHEREAS, The Board of Supervisors adopted Resolution number 549-98
9 authorizing the Private Industry Council (PIC) to accept and expend federal refugee funds
10 in an amount not to exceed \$1,500,000 in conformance with the Refugee County Plan for
11 Federal Fiscal Year (FFY) 1998 ; and

12 WHEREAS, the Board of Supervisors placed these funds on reserve, releasing
13 \$1,165,638 on September 15, 1998; and

14 WHEREAS, the PIC now has exact figures for the additional funds and requests the
15 \$334,362 that remains on reserve to be released; and

16 WHEREAS, the PIC has received \$26,121 in additional formula funds; and

17 WHEREAS, the PIC has received \$175,614 in Targeted Assistance (TA)
18 Discretionary funds; and

19 WHEREAS, These funds have been incorporated into the Refugee County Plan;
20 now therefore be it

21 RESOLVED, The President of the PIC is authorized by the Board of Supervisors to
22 expend, retroactive to October 1, 1998, \$334,362 in formula funds previously on reserve,
23 additional formula funds in the amount of \$26,121, and TA Discretionary funds in the
24 amount of \$175,614 in line with the Refugee County Plan.


