

1 [Appointments, Children, Youth and Their Families Oversight and Advisory Committee - Mia
2 "Tu Mutch" Satya, Maria Waters, Anwar Mojammel, Alyson Lee-Suzuki, and Rob Gitin]

3 **Motion appointing Mia "Tu Mutch" Satya, Maria Waters, Anwar Mojammel, Alyson Lee-**
4 **Suzuki (residency requirement waived), and Rob Gitin, terms yet to be determined, to**
5 **the Children, Youth and Their Families Oversight and Advisory Committee.**

7 MOVED, That the Board of Supervisors of the City and County of San Francisco does
8 hereby appoint the hereinafter designated persons to serve as members of the Children,
9 Youth and Their Families Oversight and Advisory Committee, pursuant to the provisions of
10 Administrative Code, Sections 2A.233-2A.234, and Charter, Section 16.108-1, for the terms
11 specified:

12 Mia "Tu Mutch" Satya, seat 7, new appointment, shall be a person who is a
13 disconnected transitional-aged youth, as that term is used in Charter, Section 16.108, 18
14 through 24 years of age at the time of appointment, and who is familiar with the issues and
15 challenges faced by disconnected transitional-aged youth and with services, programs, and
16 systems for them, for a two-year term yet to be determined.

17 Maria Waters, seat 8, new appointment, shall be a parent or guardian of a child, which
18 child is enrolled in kindergarten through 8th grade at the time of the member's appointment for
19 the term. This member shall be from a low-income community or have expertise or
20 substantial experience working to promote the interests of communities of color and shall
21 have demonstrated a commitment to improving access and quality of services for children,
22 youth and families, for a two-year term yet to be determined.

23 Anwar Mojammel, seat 9, new appointment, shall be a parent or guardian of a child,
24 which child, at the time of the member's appointment for the term, is under the age of 5 years
25 and enrolled in a publicly-subsidized or City-funded program. This member shall have

1 demonstrated a commitment to improving access and quality of services for children, youth
2 and families, for a three-year term yet to be determined.

3 Alyson Lee-Suzuki (residency requirement waived), seat 10, new appointment, shall be
4 a person with expertise or substantial experience working in the field of children and youth
5 services in communities that are low-income or underserved, for a two-year term yet to be
6 determined.

7 Rob Gitin, seat 11, new appointment, shall be a person who has demonstrated
8 commitment to improving access to and quality of services for children, youth and families, for
9 a three-year term yet to be determined.

10 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 11 1. The membership of the Children, Youth and Their Families Oversight and Advisory
12 Committee has a goal to be representative of the diversity of the City and County of
13 San Francisco.
- 14 2. Applicant Alyson Lee-Suzuki, who is not a resident of San Francisco, is a person with
15 experience that uniquely qualifies her to serve on the Children, Youth and Their
16 Families Oversight and Advisory Committee.
- 17 3. The Children, Youth and Their Families Oversight and Advisory Committee has
18 attempted to fill the position, for which Alyson Lee-Suzuki was nominated, with an
19 individual who is a City resident and who has the specific experience, skills, and
20 qualifications, but has been unable to do so at this time. The Rules Committee has
21 certified that Alyson Lee-Suzuki is qualified to serve on the Children, Youth and Their
22 Families Oversight and Advisory Committee.
- 23 4. After exercising due diligence, the Board of Supervisors concludes that there is no
24 other possible representative, who is a resident of San Francisco, and who has the
25 specific experience, skills, or qualifications possessed by this applicant, and who is

1 willing to serve on the Children, Youth and Their Families Oversight and Advisory
2 Committee at this time; and, be it

3 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
4 for Alyson Lee-Suzuki, as allowed in cases where no qualified City resident, willing to serve,
5 can be found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to
6 boards, commissions, and advisory bodies established by legislative act of the Board of
7 Supervisors to be resident(s) of the City and County of San Francisco.
