

1 [Lease and Use Agreement Modifications - Air France, and Cathay Pacific Airways, Limited -  
2 Estimated Minimum Combined Rent of \$29,666,807.61]

3 **Resolution approving Modification No. 1 to 2011 Lease and Use Agreement No. L10-**  
4 **0076 with Air France, and Modification No. 2 to L10-0081 with Cathay Pacific Airways**  
5 **Limited, and the City and County of San Francisco, acting by and through its Airport**  
6 **Commission, for changes in demised premises, with an estimated minimum combined**  
7 **rent of \$29,666,807.61 for the remainder of the lease terms expiring on June 30, 2021.**

9 WHEREAS, Air France entered into the 2011 Lease and Use Agreement No. L10-0076  
10 ("L10-0076") pursuant to Airport Commission Resolution No. 10-0076 adopted on  
11 March 16, 2010, and Board of Supervisors Resolution No. 208-10 adopted on May 11, 2010,  
12 which commenced on July 1, 2011; and

13 WHEREAS, Cathay Pacific Airways Limited ("Cathay Pacific") entered into the 2011  
14 Lease and Use Agreement No. L10-0081 ("L10-0081") pursuant to Airport Commission  
15 Resolution No. 10-0081 adopted on March 16, 2010, and Board of Supervisors Resolution  
16 No. 208-10 adopted on May 11, 2010, which commenced on July 1, 2011;<sup>7</sup> and

17 WHEREAS, By Resolution No. 15-0034 adopted on February 3, 2015, the Airport  
18 Commission approved Modification No. 1 to L10-0076 with Air France for the removal of  
19 approximately 2,510 square feet and the addition of approximately 5,268 square feet to its  
20 demised premises, for a net gain of approximately 2,758 square feet of Exclusive Category II  
21 Space ("Air France's Modification No. 1"); and

22 WHEREAS, By Resolution No. 15-0035 also adopted on February 3, 2015, the Airport  
23 Commission approved Modification No. 2 to L10-0081 with Cathay Pacific for the addition of  
24 approximately 3,790 square feet of Exclusive Category II Space to its demised premises  
25 ("Cathy Pacific's Modification No. 2"); and

1           WHEREAS, Based on projected adjustments to the Airport's Rates and Charges, the  
2 estimated minimum rent under L10-0076 with Air France is \$11,857,892.64, and  
3 \$17,808,914.97 under L10-0081 with Cathay Pacific for the remainder of the lease terms; and

4           WHEREAS, A copy of the form of Air France's Modification No. 1 and Cathay Pacific's  
5 Modification No. 2 are on file with the Clerk of the Board of Supervisors, in File No. 150211,  
6 which is hereby declared to be a part of this resolution as if set forth fully herein; now,  
7 therefore, be it

8           RESOLVED, That this Board of Supervisors hereby approves and authorizes the  
9 execution of Modification No. 1 to 2011 Lease and Use Agreement No. L10-0076 between Air  
10 France and the City and County of San Francisco, acting by and through its Airport  
11 Commission, with an estimated minimum rent of \$11,857,892.64 over the remainder of the  
12 term, which expires on June 30, 2021; and, be it

13           FURTHER RESOLVED, That this Board of Supervisors hereby approves and  
14 authorizes the execution of Modification No. 2 to 2011 Lease and Use Agreement No. L10-  
15 0081 between Cathay Pacific Airways Limited and the City and County of San Francisco,  
16 acting by and through its Airport Commission, with an estimated minimum rent of  
17 \$17,808,914.97 over the remainder of the term, which expires on June 30, 2021; and, be it

18           FURTHER RESOLVED, That within thirty (30) days of the Modifications being fully  
19 executed by all parties, the Airport Commission shall provide a copy of the final Modifications  
20 to the Clerk of the Board for inclusion into the official file.


